SENATE RESOLUTION

ENCOURAGING THE COUNTIES TO FORM PARTNERSHIPS WITH THE STATE AND
PRIVATE SECTOR TO COVER HEALTHCARE INFRASTRUCTURE AND
OVERHEAD COSTS FOR PRIMARY CARE AND SPECIALTY PHYSICIANS
PRACTICING MEDICINE IN HAWAII'S RURAL AREAS.

1 WHEREAS, many rural areas of our state especially on our
2 Neighbor Islands have been designated as health professional
3 shortage areas by the federal government; and
4

5 WHEREAS, a designation as a health professional shortage
6 area may include places with large groups of people who face
7 economic, cultural or linguistic barriers to healthcare or where
8 there are too many people in that geographic area to be served
9 by the limited number of health professionals; and

11 WHEREAS, there is a critical shortage of all healthcare
12 providers on our Neighbor Islands as Hawaii rapidly loses
13 physicians who leave to practice on the mainland for more money,
14 and many who continue to practice in this state are aging and
15 close to retirement; and

17 WHEREAS, Hawaii physicians are overly burdened by medical
18 malpractice premiums that continue to rise sharply especially
19 for orthopedists, general surgeons, and
20 obstetrician/gynecologists; and

22 WHEREAS, other states offer physicians better
23 reimbursements that are adequate to sustain their practices; and

25 WHEREAS, local healthcare facilities are straining to
26 provide their physicians with fair and adequate wages in their
27 attempts to maintain services and retain necessary staff; and



1 WHEREAS, according to a study prepared by the accounting
2 firm Ernst & Young LLP, Hawaii hospitals spent \$228 million in
3 unreimbursed funds to care for Medicare, Medicaid, and QUEST
4 patients in 2006; and

5
6 WHEREAS, some relief must be provided somewhere for
7 healthcare professionals to keep them practicing in Hawaii and
8 to encourage them to practice in the areas of the state where
9 they are most desperately needed; and

11 WHEREAS, our community health centers provide some relief
12 for rural areas but a more comprehensive approach needs to be
13 established to provide primary healthcare services; and

14
15 WHEREAS, the State, counties, and private organizations
16 have the means to support medical operations in rural areas; and

17
18 WHEREAS, providing the necessary healthcare infrastructure
19 and overhead costs for primary care and specialty physicians is
20 a viable means for reducing costs associated with practicing
21 medicine; and

22
23 WHEREAS, state, county, and private partnerships formed to
24 provide these infrastructure and overhead costs in rural areas
25 would help to overcome geographic and economic barriers which
26 plague the Neighbor Islands and ease the critical healthcare
27 shortages they face; and

29 WHEREAS, only through such a healthcare cooperative venture
30 between the State, counties, and private entities will
31 independent healthcare providers be able to practice medicine in
32 rural areas of the state; now, therefore,

34 BE IT RESOLVED by the Senate of the Twenty-fourth
35 Legislature of the State of Hawaii, Regular Session of 2007,
36 that the counties of Hawaii are encouraged to form partnerships
37 with the State and private sector to cover healthcare
38 infrastructure and overhead costs for primary care and specialty
39 physicians in Hawaii's rural, underserved areas; and



BE IT FURTHER RESOLVED that certified copies of this Resolution be transmitted to the Mayor of the County of Hawaii, Mayor of the County of Maui, Mayor of the County Kauai, Mayor of the City and County of Honolulu, Governor, Director of Health, and Executive Director of the Healthcare Association of Hawaii.
