SENATE RESOLUTION

SUPPORTING THE OFFICE OF HAWAIIAN AFFAIRS NATION-BUILDING PLAN,
HO'OU LU LĀHUI ALOHA, TO RAISE A BELOVED NATION.

1 WHEREAS, the Office of Hawaiian Affairs was created by
2 delegates to the Constitutional Convention of Hawaii of 1978 to
3 right the wrongs suffered by the indigenous people of the
4 Hawaiian Islands; and

5
6 WHEREAS, delegates to the Constitutional Convention
7 proposed a constitutional amendment to establish the Office of
8 Hawaiian Affairs as a public trust, with the mandate to better
9 the conditions of Native Hawaiians and the Hawaiian community in
10 general; and

11
12 WHEREAS, through Act 196, Session Laws of Hawaii 1979,
13 codified as chapter 10, Hawaii Revised Statutes, the Office of
14 Hawaiian Affairs was established as a semi-autonomous "self-
15 governing body"; and

16
17 WHEREAS, the Office of Hawaiian Affairs is the sole
18 representative of the Hawaiian community with financial
19 resources that include a public trust and state funds to assist
20 Native Hawaiians and improve the conditions of the Hawaiian
21 community; and

22
23 WHEREAS, programs and services benefiting Native Hawaiians
24 are now in jeopardy because of legal challenges, as the number
25 of lawsuits filed has increased ten-fold and plaintiffs have
26 been persistent in advancing their cases; and

27
28 WHEREAS, funding for programs, services, and entitlements
29 that benefit and improve the lives of Native Hawaiians are now
30 in danger of being reduced or eliminated; and

32 WHEREAS, the Native Hawaiian Government Reorganization Act
33 of 2007, S. 310 in the United States Senate and H.R. 505 in the
34 United States House of Representatives, also known as the "Akaka



1 Bill" has not received a full discussion and vote in Congress;
2 and
3

4 WHEREAS, the Office of Hawaiian Affairs, with participation
5 from the Native Hawaiian community, is spearheading the creation
6 of a Native Hawaiian governing entity that is recognized by the
7 State of Hawaii and the United States government; and
8

9 WHEREAS, the Office of Hawaiian Affairs created a formal
10 document, The Nation-Building Plan to Establish a Native
11 Hawaiian Governing Entity, with participation from the Native
12 Hawaiian community and the State of Hawaii to enable Native
13 Hawaiians to preside over their own resources and assets and
14 determine their own future; and
15

16 WHEREAS, the nation-building plan is being underwritten by
17 the Office of Hawaiian Affairs and includes the following
18 components:
19

- 20 (1) Registration of Native Hawaiians in Kau Inoa, a
21 campaign that gathers the names of people of Hawaiian
22 ancestry who are willing to participate in the process
23 of nation building;
24
- 25 (2) Development of an apportionment plan of representative
26 districts based on the eligible voter population;
27
- 28 (3) Election of representative delegates who will attend a
29 constitutional convention;
30
- 31 (4) Convening of a constitutional convention to create
32 organic documents of the Native Hawaiian governing
33 entity; and
34
- 35 (5) Ratification of the organic documents and its
36 articles;
37

38 WHEREAS, the ratified organic documents and its articles
39 will form the Native Hawaiian governing entity; now, therefore,


41 BE IT RESOLVED by the Senate of the Twenty-fourth

43 that the Legislature supports the Office of Hawaiian Affairs'
