B&F opposed this bill.


Your Committee has amended this bill by:

- (1) Applying the online disclosure to state "awards" rather  
than "funding";
- (2) Adding an appropriation for the establishment of the  
website; and
- (3) Making technical, nonsubstantive amendments for clarity,  
consistency, and style.
