Sir:

Your Committee on Finance, to which was referred H.B. No. 1572 entitled:

"A BILL FOR AN ACT MAKING APPROPRIATIONS FOR COLLECTIVE BARGAINING COST ITEMS,"

begs leave to report as follows:

The purpose of this bill is to fund:

- (1) All collective bargaining salary increases and cost items in the agreement negotiated with the exclusive bargaining representative of collective bargaining unit (1); and
- (2) The salary increases and other cost adjustments authorized by Chapter 89C, Hawaii Revised Statutes, for state officers and employees who are excluded from collective bargaining.

The Judiciary and Hawaii Government Employees Association Managerial and Confidential Employees Chapter testified in support of this bill. The Office of Collective Bargaining supported the intent of this measure.

Although no sums have been appropriated or authorized from the sources of funding indicated in this measure, your Committee believes that a vehicle for funding these collective bargaining cost items, including salary increases and other cost adjustments,



should continue to advance in the Legislature as negotiations between the State and the exclusive bargaining representative for unit (1) will eventually produce a settlement.
