Your Committee on Finance, to which was referred H.B. No. 211  
entitled:

"A BILL FOR AN ACT RELATING TO THE ISSUANCE OF SPECIAL  
PURPOSE REVENUE BONDS TO ASSIST NOT-FOR-PROFIT CORPORATIONS  
THAT PROVIDE HEALTH CARE FACILITIES TO THE GENERAL PUBLIC,"

begs leave to report as follows:

The purpose of this bill is to extend from June 30, 2008, to  
June 30, 2012, the date on which the authorization to issue  
special purpose revenue bonds to assist the Queen's Health Systems  
is to lapse.

The Healthcare Association of Hawaii testified in support of  
this bill. The Queen's Health Systems and The Queen's Medical  
Center supported this measure with amendments.

Your Committee has amended this bill by:

- (1) Changing the effective date to June 30, 2008; and
- (2) Changing the lapse date to June 30, 2013.

As affirmed by the record of votes of the members of your  
Committee on Finance that is attached to this report, your  
Committee is in accord with the intent and purpose of H.B. No.  
211, as amended herein, and recommends that it pass Third Reading  
in the form attached hereto as H.B. No. 211, H.D. 1.
