Your Committee on Finance, to which was referred H.B. No. 627
entitled:

"A BILL FOR AN ACT RELATING TO THE ISSUANCE OF SPECIAL
PURPOSE REVENUE BONDS FOR HAWAII PREPARATORY ACADEMY,"

begs leave to report as follows:

The purpose of this bill is to authorize the issuance of
special purpose revenue bonds in a total amount not to exceed
\$50,000,000, to assist Hawaii Preparatory Academy in financing or
refinancing the planning, construction, and improvements of its
educational facilities in the State of Hawaii.

Hawaii Preparatory Academy and the Hawaii Association of
Independent Schools testified in support of this bill.

Your Committee has amended this bill by making technical,
nonsubstantive amendments for clarity, consistency, and style.

As affirmed by the record of votes of the members of your
Committee on Finance that is attached to this report, your
Committee is in accord with the intent and purpose of H.B. No.
627, as amended herein, and recommends that it pass Third Reading
in the form attached hereto as H.B. No. 627, H.D. 1.
