begs leave to report as follows:

The purpose of this bill is to provide expanded assistance  
and support to family caregivers by appropriating funds to expand  
the Kupuna Care Services Program in-home and access services.

The County of Hawaii Office on Aging, City and County of  
Honolulu Department of Community Services Elderly Affairs  
Division, Kokua Council, Child and Family Service, Hawaii Aging  
Advocates Coalition, Lanakila's Meals on Wheels Program, Hale  
Mahaolu, and many concerned individuals testified in support of  
this bill. A concerned individual supported the intent of this  
measure. Catholic Charities Hawaii supported this bill with  
amendments. The Department of Health provided comments.

Your Committee has amended this bill by:


- (1) Removing the appropriation amount to encourage further  
discussion;
- (2) Changing the effective date to July 1, 2020; and
- (3) Making technical, nonsubstantive amendments for clarity,  
consistency, and style.
