Your Committees on International Affairs and Health, to which was referred H.C.R. No. 129 entitled:

"HOUSE CONCURRENT RESOLUTION REQUESTING HAWAII'S CONGRESSIONAL DELEGATION TO SUPPORT THE GLOBAL DEMOCRACY PROMOTION ACT, WHICH WOULD REPEAL THE "GLOBAL GAG RULE" AND RELEASE MUCH-NEEDED FUNDS FOR INTERNATIONAL FAMILY PLANNING PROGRAMS,"

The purpose of this concurrent resolution is to request Hawaii's Congressional Delegation to support the Global Democracy Promotion Act, which would repeal the "Global Gag Rule," and release funds for international family planning programs.


