Your Committee on Finance, to which was referred H.C.R. No. 219 entitled:

"HOUSE CONCURRENT RESOLUTION URGING THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT TO REMOVE DESIGNATED UNITS AT KALIHI VALLEY HOMES FROM THE LIST OF STRUCTURES SCHEDULED FOR DEMOLITION AND TO WORK WITH THE HAWAII PUBLIC HOUSING AUTHORITY TO RENOVATE THE BUILDINGS INSTEAD,"
