Upon review of the testimonies and statement submitted by the nominee, your Committee finds that Leland Taichi Nogawa has the necessary character, experience, and qualifications to serve on the Drug Product Selection Board.

Your Committee received testimony in support of Leland Taichi Nogawa from the Department of Health.

Leland Taichi Nogawa is Pharmacy Operations Manager, Pharmerica/Honolulu, where he is responsible for the entire in-house pharmacy operation and supervises a staff of over twenty professionals and six support staff. He has been employed by the company since 2001. Mr. Nogawa has both a Doctor of Pharmacy degree and Pre-Pharmacy degree from Creighton University, and holds a Hawaii Pharmacist License.
