Madam:

Your Committee on Health, to which was referred H.B.
No. 1370, H.D. 1, entitled:

"A BILL FOR AN ACT MAKING AN EMERGENCY APPROPRIATION TO THE
DEPARTMENT OF HEALTH FOR THE ADULT MENTAL HEALTH DIVISION,"

begs leave to report as follows:

The purpose of this measure is to ensure that adult mental
health consumers are provided continuous services by making an
emergency appropriation to the Department of Health for its Adult
Mental Health Division.

Your Committee received testimony in support of this measure
from the Department of Health, the Hawaii Psychiatric Medical
Association, and one individual.

Your Committee finds that the number of adult mental health
consumers that are eligible to receive services through the
Department of Health have significantly increased. This increase
is a result of *United States v. State of Hawaii, et al.* Civil
Number 91-00137, a federal law suit that expanded the use of
available services throughout the islands. Your Committee further
finds that this emergency appropriation is necessary to ensure the
availability of continuous adult mental health services in the
State.


As affirmed by the record of votes of the members of your


