H.B. No. 154, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO MOTOR VEHICLE SAFETY,"

begs leave to report as follows:

The purpose of this measure is to redefine highly intoxicated  
driver, establish evidence and sentencing parameters, and  
establish administrative revocation periods for highly intoxicated  
drivers.

Your Committee received testimony in support of the bill from  
the State Department of Transportation, the Honolulu Prosecuting  
Attorney's Office, Mothers Against Drunk Driving, and the Century  
Council.


Your Committee amended the bill by making a technical non-  
substantive change and by changing the effective date from July 1,  
2112 to July 1, 2007.

As affirmed by the record of votes of the members of your  
Committee on Judiciary and Labor that is attached to this report,



your Committee is in accord with the intent and purpose of H.B. No. 154, H.D. 1, as amended herein, and recommends that it pass Second Reading in the form attached hereto as H.B. No. 154, H.D. 1, S.D. 1, and be placed on the calendar for Third Reading.
