Madam:

Your Committee on Education, to which was referred H.C.R.
No. 83 entitled:

"HOUSE CONCURRENT RESOLUTION REQUESTING THE BOARD OF
EDUCATION TO ASSESS THE EXTENT TO WHICH SUPPLEMENTAL ACADEMIC
ACTIVITIES ARE INCLUDED IN THE A PLUS AFTER-SCHOOL PROGRAM,"

begs leave to report as follows:

The purpose of this measure is to provide increased after
school activities for students by requesting the Department of
Education to assess the extent to which supplemental academic
services are included in the After-school Plus Program
(A+ Program).

Testimony in support of this measure was submitted by the
Department of Education.

Your Committee finds that the Department of Education's A+
Program provides affordable after-school child care services for
children in public elementary schools whose parents work, attend
school, or are in job training programs, so that the high
incidence of latchkey children is reduced. Your Committee further
finds that the A+ Program provides a safe, secure, and nurturing
environment for children after school hours and offers a rich
variety of activities for the children. Your Committee believes
that the A+ Program plays an important role in helping young
students to achieve their educational goals and realize their
potential. This measure requests the Department of Education to
assess the extent to which supplemental academic activities are
included in the A+ Program to examine whether increased academic



services can be provided to young students and allow more public school students to strive to greater heights of academic achievement.

As affirmed by the record of votes of the members of your Committee on Education that is attached to this report, your Committee concurs with the intent and purpose of H.C.R. No. 83, and recommends its adoption.
