Madam:

Your Committee on Judiciary and Labor, to which was referred
S.B. No. 1891 entitled:

"A BILL FOR AN ACT RELATING TO PUBLIC LANDS,"

begs leave to report as follows:

The purpose of this measure is to make a violation of chapter
171, Hawaii Revised Statutes, a petty misdemeanor.

Your Committee received testimony in support of this measure
from the Department of Land and Natural Resources and twelve
private citizens.

Your Committee has amended this measure by:

- (1) Increasing the minimum fine for a first offense from
\$100 to \$500;
- (2) Increasing the minimum fine for a second offense within
five years of a previous conviction for the same offense
from \$500 to \$1,000; and
- (3) Increasing the minimum fine for a third or subsequent
offense within five years of a second conviction from
\$1000 to \$2000.

As affirmed by the record of votes of the members of your
Committee on Judiciary and Labor that is attached to this report,
your Committee is in accord with the intent and purpose of S.B.
