Your Committees on Human Services and Public Housing and  
Judiciary and Labor, to which was referred S.C.R. No. 10 entitled:

"SENATE CONCURRENT RESOLUTION REQUESTING THE JUDICIARY TO  
IMPLEMENT A PILOT FAMILY COURT PARENTING PLAN MODEL PROGRAM  
IN THE FIRST CIRCUIT FAMILY COURT,"

beg leave to report as follows:

The purpose of this measure is to request the Judiciary to  
implement a pilot Family Court Parenting Plan Model Program in the  
First Circuit Family Court.

The Judiciary and Oahu VOICES submitted comments.

During interim hearings convened by the Committees on Human  
Services of the Senate and the House of Representatives, it was  
recommended that a process, known as the Family Court Parenting  
Plan Model, should exist to assist parents to develop a parenting  
plan without and prior to Family Court intervention. Further  
recommendations were made by a group of interested stakeholders  
regarding how this model should be implemented. However, it was  
agreed that the model should be implemented as a pilot program  
first so that it can be evaluated and modified before determining  
whether to implement it on a statewide, mandatory basis.

As affirmed by the records of votes of the members of your  
Committees on Human Services and Public Housing and Judiciary and  
Labor that are attached to this report, your Committees concur  
with the intent and purpose of S.C.R. No. 10 and recommend its  
adoption.
