RELATING TO HOUSING.

Extends the sunset date for the allocation of conveyance tax revenues to the rental housing trust fund and changes the allocation to an unspecified percentage; requires the Hawaii finance and development corporation to create an affordable housing inventory registry; and appropriates funds for various homeless and housing programs and projects. (SD3)


