Allows an employee to use family leave during any calendar year to provide family care and support during the military deployment of the employee's child, spouse or reciprocal beneficiary, or parent. Requires an employee to provide proof of military deployment. Defines military deployment.	PSM/LAB, FIN
HB 1077	RELATING TO HAWAII EMPLOYER-UNION HEALTH BENEFITS TRUST FUND. Requires the board of trustees of the Hawaii employer-union health benefits trust fund to establish separately health benefits plans for collective bargaining unit 12 (police officers).	LAB/PSM, FIN
HB 1399	RELATING TO INCARCERATED PERSONS. Clarifies that participation in work, education, and vocational training programs while incarcerated is exempt from statutory employee benefits.	PSM/LAB, FIN
HB 1403	RELATING TO THE HAWAII PAROLING AUTHORITY. Increases the level of service of members of the Hawaii Paroling Authority from part-time to full time.	PSM/LAB, FIN


