RELATING TO EMERGENCIES.

TAC/PSM, FIN

Allows the Hawaii tourism authority to request the governor to declare that a tourism emergency exists. Authorizes tourism authority to implement emergency measures to respond to an emergency. Establishes the Hawaii tourism emergency trust fund.


DECISION MAKING TO FOLLOW


