SB 1219 SD1 (SSCR735)	RELATING TO LAND USE. Authorizes counties to petition land use commission to reclassify agricultural lands to allow certain preexisting residential uses constructed prior to 1/1/00 to be considered a permissible use. (SD1)	WLH/AGR, JUD
SB 1236 SD1 (SSCR834)	RELATING TO LAND USE. Requires the land use commission to include the Right to Farm Act under chapter 165, Hawaii Revised Statutes, as a condition to any reclassification of land to an urban or rural district designation that is contiguous to an agricultural district. (SD1)	WLH/AGR
SB 1756 SD1 (SSCR923)	RELATING TO IMPORTANT AGRICULTURAL LANDS. Establishes a state agricultural land protection program for the voluntary acquisition of agricultural easements on lands designated as important agricultural lands. (SD1)	WLH/AGR, FIN




