SB 920	RELATING TO CONDOMINIUMS. Limits the use of the condominium association member lists by the managing agent.	CPH
SB 921	RELATING TO CONDOMINIUM ASSOCIATION RECORDS. Limits the costs the association can charge to members for association records to reasonable costs. Clarifies that reasonable costs include administrative and duplicating costs.	CPH
SB 1654	RELATING TO CONDOMINIUM MANAGEMENT DISPUTE RESOLUTION. Establishes requirements for condominium management dispute resolution.	CPH

Persons wishing to testify should submit testimony in one of the following ways at least 24 hours prior to the hearing:


- In person: 30 copies of their testimony to the committee clerk, Room 219, State Capitol.

Please indicate to which committee the testimony is being submitted, the date and time of the hearing, and the number of copies needed for submittal. In addition, please provide the testifier's name and mailing address in the email. Email sent to individual offices or any other Senate office will not be accepted.
