SB 1007 SD1 (SSCR44)	RELATING TO THE GENERAL EXCISE TAX. Requires an investment broker and agent who share compensation for their services to pay the general excise tax on only that portion of the compensation retained by each. Effective 7/1/07. (SD1)	CPH, EDT, WAM
SB 1506 SD1 (SSCR45)	RELATING TO RENTAL MOTOR VEHICLE SURCHARGE TAX. Extends the rental vehicle surcharge tax effective date beyond September 1, 2007. (SD1)	CPH/TIA, EDT, WAM
SB 1034 (SSCR37)	RELATING TO TAXATION. Exempts from general excise and use taxes the fuel sold from a foreign-trade zone for intrastate air transportation by common carriers.	TIA, EDT, WAM
