SB 664	RELATING TO SPECIAL PURPOSE REVENUE BONDS FOR SACRED HEARTS ACADEMY. Authorizes the issuance of special purpose revenue bonds for the construction and improvement of Sacred Hearts Academy, a not-for-profit private sectarian school.	EDU, WAM

SB 1027	AUTHORIZING THE ISSUANCE OF GENERAL OBLIGATION BONDS AND MAKING AN APPROPRIATION FOR A NEW SCIENCE BUILDING FOR MOLOKAI HIGH SCHOOL. Appropriates \$1,645,000 in general obligation bonds to the department of education for a new science building at Molokai high school.	EDU, WAM
SB 660	MAKING AN APPROPRIATION FOR HANA AND KA'U SCHOOLS. Appropriates \$50,000 to each school to purchase vans for student transportation.	EDU, WAM
SB 1246	MAKING AN APPROPRIATION FOR MILILANI MIDDLE SCHOOL. Provides funding for trash receptacles at Mililani Middle School.	EDU, WAM
SB 150	MAKING AN APPROPRIATION FOR CAMPBELL HIGH SCHOOL. Appropriates funds to provide an air conditioning system for James Campbell High School.	EDU, WAM
SB 759	RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE NINTH SENATORIAL DISTRICT. Appropriates funds for capital improvement projects in the ninth senatorial district.	EDU, WAM


