Persons wishing to testify should submit testimony in one of the following ways at least 24 hours prior to the hearing:


- In person: 30 copies of their testimony to the committee clerk, Room 227, State Capitol.

In addition, please provide the testifier's name and mailing address in the email. Email sent to individual offices or any other Senate office will not be accepted.
