SB 1925	RELATING TO SUSTAINABILITY. Establishes sustainable communities in Hawaii with the combined effort of state departments and agencies.	WAH, WAM
SB 1235	RELATING TO HAWAIIAN HOME LANDS. Establishes a task force on Hawaiian homestead community self-governance to begin the process of delegating authority for the administration of the Hawaiian Homes Commission Act, 1920, to Hawaiian homestead community self-governance organizations.	WAH, WAM
SB 938	RELATING TO THE HAWAIIAN HOMES COMMISSION ACT. Provides for consultation with beneficiaries when a project includes commercial development.	WAH
SB 939	RELATING TO THE HAWAIIAN HOMES COMMISSION ACT, 1920, AS AMENDED. Establishes the Hawaiian home lands community development fund with revenue-sharing from commercial development projects in order to fund community and cultural programming for beneficiaries of the trust in the Hawaiian homestead communities.	WAH, WAM
SB 940	RELATING TO HAWAIIAN HOMES COMMISSION ACT 1920, AS AMENDED. Requires the department of Hawaiian home lands to consult with the beneficiaries of the trust before agreeing to lower allowable loan amounts.	WAH, WAM
SB 929	RELATING TO HAWAIIAN HOMES COMMISSION. Requires the presentation to the neighborhood board or community association for any development by the department of Hawaiian home lands.	WAH, WAM
SB 1439	RELATING TO THE HAWAIIAN HOMES COMMISSION ACT, 1920, AS AMENDED. Authorizes the transfer of moneys fro the Hawaiian home receipts fund to the native Hawaiian rehabilitation fund.	WAH, WAM



SB 1440 RELATING TO THE HAWAIIAN HOMES COMMISSION ACT, WAH
1920, AS AMENDED.
Authorizes the department to prescribe via administrative rules terms,
conditions, and restrictions on the transfer of homestead leases.

SB 1853 RELATING TO NATIVE HAWAIIANS. WAH, WAM
Establishes Aha Moku Commission to assist in the formation regional
Aha Moku Councils which shall serve as in an advisory capacity on all
matters regarding the management of the state's natural resources.
Requires the Department of Land and Natural Resources to seek
advisory assistance from the Aha Moku Councils in developing a
comprehensive set of best practices for natural resource management.


Decision Making to follow, if time permits.
