# A BILL FOR AN ACT

RELATING TO STATUTORY REVISION: AMENDING OR REPEALING VARIOUS PROVISIONS OF THE HAWAII REVISED STATUTES AND THE SESSION LAWS OF HAWAII FOR THE PURPOSE OF CORRECTING ERRORS AND REFERENCES, CLARIFYING LANGUAGE, AND DELETING OBSOLETE OR UNNECESSARY PROVISIONS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. Section 6E-11, Hawaii Revised Statutes, is  
2 amended by amending subsection (a) to read as follows:

3 "(a) It shall be a civil and administrative violation for  
4 any person to take, appropriate, excavate, injure, destroy, or  
5 alter any historic property or aviation artifact located upon  
6 the private lands of any owner thereof without the owner's  
7 written permission being first obtained. It shall be a civil  
8 and administrative violation for any person to take,  
9 appropriate, excavate, injure, destroy, or alter any historic  
10 property or aviation artifact located upon lands owned or  
11 [†]controlled by the State or any of its political  
12 subdivisions, [†] except as permitted by the department, or to  
13 knowingly violate the conditions set forth in an approved  
14 mitigation plan that includes monitoring and preservation  
15 plans."



1 SECTION 2. Section 36-27, Hawaii Revised Statutes, is  
2 amended to read as follows:

3 **"§36-27 Transfers from special funds for central service**  
4 **expenses.** Except as provided in this section, and  
5 notwithstanding any other law to the contrary, from time to  
6 time, the director of finance, for the purpose of defraying the  
7 prorated estimate of central service expenses of government in  
8 relation to all special funds, except the:

14 shall deduct five per cent of all receipts of all other special  
15 funds, which deduction shall be transferred to the general fund  
16 of the State and become general realizations of the State. All  
17 officers of the State and other persons having power to allocate  
18 or disburse any special funds shall cooperate with the director  
19 in effecting these transfers. To determine the proper revenue  
20 base upon which the central service assessment is to be  
21 calculated, the director shall adopt rules pursuant to chapter  
22 91 for the purpose of suspending or limiting the application of



1 the central service assessment of any fund. No later than  
2 twenty days prior to the convening of each regular session of  
3 the legislature, the director shall report all central service  
4 assessments made during the preceding fiscal year.[+]"

5 SECTION 3. Section 36-30, Hawaii Revised Statutes, is  
6 amended by amending subsection (a) to read as follows:

7 "(a) Each special fund, except the:

9           SECTION 4. Section 84-17, Hawaii Revised Statutes, is  
10 amended by amending subsection (c) to read as follows:

11           "(c) The following persons shall file annually with the  
12 state ethics commission a disclosure of financial interests:

13           (1) The governor, the lieutenant governor, the members of  
14                 the legislature, and delegates to the constitutional  
15                 convention; provided that delegates to the  
16                 constitutional convention shall only be required to  
17                 file initial disclosures;

18           (2) The directors and their deputies, the division chiefs,  
19                 the executive directors and the executive secretaries  
20                 and their deputies, the purchasing agents and the  
21                 fiscal officers, regardless of the titles by which the



- 1           foregoing persons are designated, of every state  
2           agency and department;
- 3           (3) The permanent employees of the legislature and its  
4           service agencies, other than persons employed in  
5           clerical, secretarial, or similar positions;
- 6           (4) The administrative director of the State, and the  
7           assistants in the office of the governor and the  
8           lieutenant governor, other than persons employed in  
9           clerical, secretarial, or similar positions;
- 10          (5) The hearings officers of every state agency and  
11          department;
- 12          (6) The president, the vice presidents, assistant vice  
13          presidents, the chancellors, and the provosts of the  
14          University of Hawaii and its community colleges;
- 15          (7) The superintendent, the deputy superintendent, the  
16          assistant superintendents, the complex area  
17          superintendents, the state librarian, and the deputy  
18          state librarian of the department of education;
- 19          (8) The administrative director and the deputy director of  
20          the courts;
- 21          (9) The members of every state board or commission whose  
22          original terms of office are for periods exceeding one

6 (10) Candidates for state elective offices, including  
 7 candidates for election to the constitutional  
 8 convention, provided that candidates shall only be  
 9 required to file initial disclosures; and

10 (11) The administrator and assistant administrator of the  
 11 office of Hawaiian affairs."

12 SECTION 5. Section 132D-16, Hawaii Revised Statutes, is  
 13 amended by amending subsection (c) to read as follows:

14 "(c) No permit shall be issued under this section unless  
 15 the applicant presents, at the applicant's option, either:

16 (1) A written certificate of an insurance carrier, which  
 17 has been issued to or for the benefit of the  
 18 applicant, or a policy providing for the payment of  
 19 damages in the amount of not less than \$5,000 for  
 20 injury to, or death of, any one person, and subject to  
 21 the foregoing limitation for one person; in the amount  
 22 of not less than \$10,000 for injury to, or death of,



1 two or more persons; and in the amount of not less  
2 than \$5,000 for damage to property, caused by reason  
3 of the authorized display and arising from any  
4 tortious acts or negligence of the permittee, the  
5 permittee's agents, employees, or subcontractors. The  
6 certificate shall state that the policy is in full  
7 force and effect and will continue to be in full force  
8 and effect for not less than ten days after the date  
9 of the display; or

- 10 (2) The bond of a surety company duly authorized to  
11 transact business within the State, or a bond with not  
12 less than two individual sureties who together have  
13 assets in the State equal in value to not less than  
14 twice the amount of the bond, or a deposit of cash, in  
15 the amount of not less than \$10,000 conditioned upon  
16 the payment of all damages that may be caused to any  
17 person or property by reason of the authorized display  
18 and arising from any tortious acts or negligence of  
19 the permittee, the permittee's agents, employees, or  
20 subcontractors. The security shall continue to be in  
21 full force and effect for not less than ten days after  
22 the date of the display.



1           The county may require coverage in amounts greater than the  
2 minimum amounts set forth in paragraph (1) or (2) if deemed  
3 necessary or desirable in consideration of such factors as the  
4 location and scale of the display, the type of aerial devices,  
5 [{}display[{}] fireworks, or articles pyrotechnic to be used, and  
6 the number of spectators expected."

7           SECTION 6. Section 134-2, Hawaii Revised Statutes, is  
8 amended as follows:

9           1. By amending subsection (a) to read:

10           "(a) No person shall acquire the ownership of a firearm,  
11 whether usable or unusable, serviceable or unserviceable, modern  
12 or antique, registered under prior law or by a prior owner or  
13 unregistered, either by purchase, gift, inheritance, bequest, or  
14 in any other manner, whether procured in the State or imported  
15 by mail, express, freight, or otherwise, until the person has  
16 first procured from the chief of police of the county of the  
17 person's place of business or, if there is no place of business,  
18 the person's residence or, if there is neither place of business  
19 nor residence, the person's place of sojourn, a permit to  
20 acquire the ownership of a firearm as prescribed in this  
21 section. When title to any firearm is acquired by inheritance  
22 or bequest, the foregoing permit shall be obtained before taking



1 possession of a firearm; provided that upon presentation of a  
 2 copy of the death certificate of the owner making the bequest,  
 3 any heir or legatee may transfer the inherited or bequested  
 4 firearm directly to a dealer licensed under section 134-31 or  
 5 licensed by the United States Department of [~~the Treasury~~  
 6 Justice without complying with the requirements of this  
 7 section."

8 2. By amending subsection (e) to read:

9 "(e) The permit application form shall be signed by the  
 10 applicant and by the issuing authority. One copy of the permit  
 11 shall be retained by the issuing authority as a permanent  
 12 official record. Except for sales to dealers licensed under  
 13 section 134-31, or dealers licensed by the United States  
 14 Department of Justice, or law enforcement officers, or where a  
 15 license is granted under section 134-9, or where any firearm is  
 16 registered pursuant to section 134-3(a), no permit shall be  
 17 issued to an applicant earlier than fourteen calendar days after  
 18 the date of the application; provided that a permit shall be  
 19 issued or the application denied before the twentieth day from  
 20 the date of application. Permits issued to acquire any pistol  
 21 or revolver shall be void unless used within ten days after the  
 22 date of issue. Permits to acquire a pistol or revolver shall



1 require a separate application and permit for each transaction.  
2 Permits issued to acquire any rifle or shotgun shall entitle the  
3 permittee to make subsequent purchases of rifles or shotguns for  
4 a period of one year from the date of issue without a separate  
5 application and permit for each acquisition, subject to the  
6 disqualifications under section 134-7 and subject to revocation  
7 under section 134-13; provided that if a permittee is arrested  
8 for committing a felony or any crime of violence or for the  
9 illegal sale of any drug, the permit shall be impounded and  
10 shall be surrendered to the issuing authority. The issuing  
11 authority shall perform an inquiry on an applicant who is a  
12 citizen of the United States by using the National Instant  
13 Criminal Background Check System before any determination to  
14 issue a permit or to deny an application is made. If the  
15 applicant is not a citizen of the United States and may be  
16 eligible to acquire a firearm under this chapter, the issuing  
17 authority shall perform an inquiry on the applicant, by using  
18 the National Instant Criminal Background Check System, to  
19 include a check of the Immigration and Customs Enforcement  
20 databases, [~~where the applicant is not a citizen of the United~~  
21 ~~States,~~] before any determination to issue a permit or to deny  
22 an application is made."



1 SECTION 7. Section 134-3, Hawaii Revised Statutes, is  
2 amended by amending subsections (c) and (d) to read as follows:

3 "(c) Dealers licensed under section 134-31 or dealers  
4 licensed by the United States Department of [~~the Treasury~~]  
5 Justice shall register firearms pursuant to this section on  
6 registration forms prescribed by the attorney general and shall  
7 not be required to have the firearms physically inspected by the  
8 chief of police at the time of registration.

9 (d) Registration shall not be required for:

- 10 (1) Any device that is designed to fire loose black powder  
11 or that is a firearm manufactured before 1899;
- 12 (2) Any device not designed to fire or made incapable of  
13 being readily restored to a firing condition; or
- 14 (3) All unserviceable firearms and destructive devices  
15 registered with the Bureau of Alcohol, Tobacco, and  
16 Firearms of the United States Department of [~~the~~  
17 ~~Treasury~~] Justice pursuant to Title 27, Code of  
18 Federal Regulations."

19 SECTION 8. Section 134-9, Hawaii Revised Statutes, is  
20 amended by amending subsection (a) to read as follows:

21 "(a) In an exceptional case, when an applicant shows  
22 reason to fear injury to the applicant's person or property, the



1 chief of police of the appropriate county may grant a license to  
2 an applicant who is a citizen of the United States of the age of  
3 twenty-one years or more or to a duly accredited official  
4 representative of a foreign nation of the age of twenty-one  
5 years or more to carry a pistol or revolver and ammunition  
6 therefor concealed on the person within the county where the  
7 license is granted. Where the urgency or the need has been  
8 sufficiently indicated, the respective chief of police may grant  
9 to an applicant of good moral character who is a citizen of the  
10 United States of the age of twenty-one years or more, is engaged  
11 in the protection of life and property, and is not prohibited  
12 under section 134-7 from the ownership or possession of a  
13 firearm, a license to carry a pistol or revolver and ammunition  
14 therefor unconcealed on the person within the county where the  
15 license is granted. The chief of police of the appropriate  
16 county, or the chief's designated representative, shall perform  
17 an inquiry on an applicant by using the National Instant  
18 Criminal Background Check System, to include a check of the  
19 Immigration and Customs Enforcement databases[7] where the  
20 applicant is not a citizen of the United States, before any  
21 determination to grant a license is made. Unless renewed, the  
22 license shall expire one year from the date of issue."



1 SECTION 9. Section 195F-4, Hawaii Revised Statutes, is  
2 amended by amending subsection (a) to read as follows:

3 "(a) There is established a special fund within the state  
4 treasury known as the forest stewardship fund which shall be used  
5 as follows:

6 (1) Payments shall be made by the board pursuant to  
7 agreements entered into with qualified landowners to  
8 further the purposes of this chapter;

9 (2) Moneys collected from:

10 (A) The harvest of non-native forest products from  
11 forest reserves;

12 (B) The harvest of native forest products from  
13 degraded forests as defined in section 186-5.5,  
14 within forest reserves;

15 (C) The sale of forest products found dead and lying  
16 on the ground;

17 (D) The sale of tree seedlings from state nurseries;

18 (E) The sale of any other products or services, or  
19 anything of value derived from forest reserves  
20 not described above; or





1 (F) The imposition of fines or penalties for  
2 violations of this chapter and chapters 183 and  
3 185 [~~and 195F~~] or any rule adopted thereunder;  
4 shall be used for: (i) [~~Replanting,~~] replanting,  
5 managing, and maintaining designated timber management  
6 areas; (ii) [~~Enhancing~~] enhancing the management of  
7 public forest reserves with an emphasis on restoring  
8 degraded koa forests; and (iii) [~~Developing~~] developing  
9 environmental education and training programs  
10 pertaining to sustainable forestry; provided that the  
11 activities described in clauses (ii) and (iii) may not  
12 be funded unless the activities described in approved  
13 management plans pertaining to clause (i) are  
14 adequately funded; and

15 (3) Moneys deposited into the fund as authorized by section  
16 247-7 may also be used by the department to administer  
17 the program and manage the forest reserve system."

18 SECTION 10. Section 211G-13, Hawaii Revised Statutes, is  
19 amended by amending subsection (e) to read as follows:

20 "(e) In carrying out the mission of the corporation, as  
21 authorized in this chapter, neither the corporation nor its  
22 officers, board members, or employees shall be considered to be



1 broker-dealers, agents, investment advisors, or investment  
2 adviser representatives under chapter [~~485.~~] 485A. The tax  
3 credits issued or transferred pursuant to this chapter shall not  
4 be considered securities under chapter [~~485.~~] 485A."

5 SECTION 11. Section 235-51, Hawaii Revised Statutes, is  
6 amended by amending subsection (b) to read as follows:

7 "(b) There is hereby imposed on the taxable income of  
8 every head of a household a tax determined in accordance with  
9 the following table:

7 SECTION 12. Section 235-110.7, Hawaii Revised Statutes, is  
8 amended as follows:

9 1. By amending subsections (a) and (b) to read:

10 "(a) There shall be allowed to each taxpayer subject to  
11 the tax imposed by this chapter a capital goods excise tax  
12 credit which shall be deductible from the taxpayer's net income  
13 tax liability, if any, imposed by this chapter for the taxable  
14 year in which the credit is properly claimed.

15 The amount of the tax credit shall be determined by the  
16 application of the following rates against the cost of the  
17 eligible depreciable tangible personal property used by the  
18 taxpayer in a trade or business and placed in service within  
19 Hawaii after December 31, 1987. For calendar years beginning  
20 after: December 31, 1987, the applicable rate shall be three  
21 per cent; December 31, 1988, and thereafter, the applicable rate  
22 shall be four per cent [~~except that for the period January 1,~~



1 ~~1993, through December 31, 2002, and for eligible depreciable~~  
2 ~~tangible personal property used in a trade or business that is~~  
3 ~~purchased in a county in which the county general excise and use~~  
4 ~~tax surcharge is in effect and placed in service in any county~~  
5 ~~the applicable rate shall be four and one-half per cent]. For~~  
6 taxpayers with fiscal taxable years, the applicable rate shall  
7 be the rate for the calendar year in which the eligible  
8 depreciable tangible personal property used in the trade or  
9 business is placed in service within Hawaii.

10 In the case of a partnership, S corporation, estate, or  
11 trust, the tax credit allowable is for eligible depreciable  
12 tangible personal property which is placed in service by the  
13 entity. The cost upon which the tax credit is computed shall be  
14 determined at the entity level. Distribution and share of  
15 credit shall be determined by rules.

16 In the case of eligible depreciable tangible personal  
17 property for which a credit for sales or use taxes paid to  
18 another state is allowable under section 238-3(i), the amount of  
19 the tax credit allowed under this section shall not exceed the  
20 amount of use tax[, ~~and for the period January 1, 1993, through~~  
21 ~~December 31, 2002, the amount of the county general excise and~~



1 ~~use tax surcharge,~~] actually paid under chapter 238 relating to  
2 such tangible personal property.

3 If a deduction is taken under section 179 (with respect to  
4 election to expense certain depreciable business assets) of the  
5 Internal Revenue Code of 1954, as amended, no tax credit shall  
6 be allowed for that portion of the cost of property for which  
7 the deduction was taken.

8 (b) ~~[If the tax credit is claimed by a taxpayer at the  
9 rate of four and one-half per cent, and the tangible personal  
10 property is purchased in a county in which the county general  
11 excise and use tax surcharge is not in effect, there shall be  
12 added to and become part of the tax liability of the taxpayer:~~

13 ~~(1) The amount of the tax credit claimed under this  
14 section multiplied by three; or  
15 (2) Ten per cent of the income tax liability for the  
16 taxable year for which the income tax return is being  
17 filed,  
18 whichever is greater.]~~

19 If the capital goods excise tax credit allowed under  
20 subsection (a) exceeds the taxpayer's net income tax liability,  
21 the excess of credit over liability shall be refunded to the  
22 taxpayer; provided that no refunds or payment on account of the



1 tax credit allowed by this section shall be made for amounts  
2 less than \$1.

3 All claims for tax credits under this section, including  
4 any amended claims, must be filed on or before the end of the  
5 twelfth month following the close of the taxable year for which  
6 the credits may be claimed. Failure to comply with the  
7 foregoing provision shall constitute a waiver of the right to  
8 claim the credit.

9 2. By amending subsection (e) to read:

10 (e) As used in this section, the definition of section 38  
11 property (with respect to investment in depreciable tangible
