
A BILL FOR AN ACT

RELATING TO CAPITAL IMPROVEMENT PROJECTS FOR THE BENEFIT OF THE
FORTY-EIGHTH REPRESENTATIVE DISTRICT.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The following sums, or so much thereof as shall
2 be sufficient to finance the projects listed in this Act, are
3 hereby appropriated out of the general revenues of the State of
4 Hawaii for fiscal year 2007-2008.

6 Windward community college, Oahu

7 Design, construction, and equipment for
8 a new library; ground and site
9 improvements; and equipment and
10 appurtenances.


