## A BILL FOR AN ACT

RELATING TO ESTABLISHING A GLOBAL YOUTH CENTER.

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. World peace is a major collaborative goal and 1 youth are the key to attaining world peace, environmental 2 sustainability, and human and economic productivity for future 3 generations. Hawaii's location at the center of the Pacific rim 4 region between Asia and the Americas, its diverse culture, and 5 its many shared languages provide an excellent strategic forum 6 for meetings and exchanges, as demonstrated by the Millennium 7 Youth People's Congress that was held in Hawaii in October 1999. 8 The purpose of this Act is to establish a global youth 9 center in Hawaii under the University of Hawaii. 10 SECTION 2. Chapter 304A, Hawaii Revised Statutes, is 11 amended by adding a new section to part IV, subpart M, to be 12 appropriately designated and to read as follows: 13 "\$304A- Global youth center; establishment. (a) There 14 is established a global youth center under the University of 15
