
A BILL FOR AN ACT

RELATING TO TRAFFIC VIOLATIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the development of
2 an electronic citation system for traffic and other types of
3 violations would significantly enhance public safety and law
4 enforcement services. An increasing number of law enforcement
5 agencies throughout the nation are implementing electronic
6 citation systems. For the city and county of Honolulu, the cost
7 of implementing an electronic system comprised of hardware,
8 software, and programming to capture, manage, and share citation
9 data has been estimated at \$1,500,000.

10 The legislature also finds that an electronic citation
11 system that allows the counties and the judiciary to share
12 information on traffic violations would provide timely
13 information for law enforcement agencies and make available
14 information on a real-time basis for investigations.

15 The purpose of this Act is to provide a source of funding
16 for the establishment and maintenance of an electronic citation
17 system through an administrative fee of \$4 per citation issued
18 for violations of the statewide traffic code.



1 SECTION 2. Chapter 291C, Hawaii Revised Statutes, is
2 amended by adding two new sections to be appropriately
3 designated and to read as follows:

4 "§291C-A Traffic violation administrative fee. Effective
5 July 1, 2008, an administrative fee of \$4 shall be assessed on
6 each citation issued for a violation of chapter 291C, the
7 statewide traffic code. Revenue from the administrative fee
8 shall fund the establishment and maintenance of an electronic
9 citation system. All revenue collected pursuant to this section
10 shall be deposited into the electronic citation system special
11 fund established in section 291C-B.

12 §291C-B Electronic citation system special fund. (a)
13 There is established in the state treasury a special fund to be
14 known as the electronic citation system special fund to be
15 administered by the department of budget and finance. Any funds
16 appropriated by the legislature for the electronic citation
17 system, administrative fees assessed under section 291C-A, and
18 interest accrued on moneys deposited in the fund shall become a
19 part of the fund. Moneys in the fund or disbursed from the fund
20 pursuant to subsection (b) shall be expended to establish an
21 electronic citation system.



1 (b) Administrative fees deposited in the fund pursuant to
2 section 291C-A shall be shared equally by the judiciary and the
3 county police department that issued the citation. Effective
4 July 1, 2009, the director of finance shall transmit not more
5 than thirty days after the end of each fiscal quarter, fifty per
6 cent of the administrative fee assessed on each citation to:

- 7 (1) The county police department that issued the citation;
8 and
9 (2) The judiciary."

10 SECTION 3. Section 36-27, Hawaii Revised Statutes, is
11 amended to read as follows:

12 "**§36-27 Transfers from special funds for central service**
13 **expenses.** Except as provided in this section, and
14 notwithstanding any other law to the contrary, from time to
15 time, the director of finance, for the purpose of defraying the
16 prorated estimate of central service expenses of government in
17 relation to all special funds, except the:

- 18 (1) Special out-of-school time instructional program fund
19 under section 302A-1310;
20 (2) School cafeteria special funds of the department of
21 education;
22 (3) Special funds of the University of Hawaii;

1 shall deduct five per cent of all receipts of all other special
2 funds, which deduction shall be transferred to the general fund
3 of the State and become general realizations of the State. All
4 officers of the State and other persons having power to allocate
5 or disburse any special funds shall cooperate with the director
6 in effecting these transfers. To determine the proper revenue
7 base upon which the central service assessment is to be
8 calculated, the director shall adopt rules pursuant to chapter
9 91 for the purpose of suspending or limiting the application of
10 the central service assessment of any fund. No later than
11 twenty days prior to the convening of each regular session of
12 the legislature, the director shall report all central service
13 assessments made during the preceding fiscal year."

14 SECTION 4. Section 36-30, Hawaii Revised Statutes, is
15 amended by amending subsection (a) to read as follows:

- 16 "(a) Each special fund, except the:

15 administrative expenses incurred by the department responsible

17 SECTION 5. In codifying the new sections added by section
18 2 of this Act, the revisor of statutes shall substitute
19 appropriate section numbers for the letters used in designating
20 the new sections in this Act.

21 SECTION 6. Statutory material to be repealed is bracketed
22 and stricken. New statutory material is underscored.



1 SECTION 7. This Act shall take effect on July 1, 2008.

Report Title:

Traffic Violations; Administrative Fee; Electronic Citations

Description:

Authorizes a \$4 administrative fee on all citations for traffic code violations to be shared by the judiciary and the counties for the establishment and maintenance of an electronic citation system. Establishes the electronic citation system special fund. Provides for the disbursement of the funds to the counties and the judiciary.
