A BILL FOR AN ACT

RELATING TO AIR POLLUTION CONTROL.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that bunker fuel is a
- 2 particularly noxious petroleum product that is used to power
- 3 some marine vessels. Bunker fuel is a heavy petroleum product
- 4 that commonly contains relatively high amounts of sulfur.
- 5 Bunker fuel is the fuel oil that was spread in harbor waters in
- 6 the 2007 massive oil spills in the Black Sea and San Francisco
- 7 Bay. Concerned citizens note that bunker fuel literally comes
- 8 from the bottom of the oil barrel as an "asphalt-like gunk" left
- 9 behind after crude oil is refined into gasoline and diesel.
- 10 Adverse health effects from inhaling fumes from the burning
- 11 of bunker fuel oil (according to the Material Safety Data Sheet,
- 12 United States Oil and Refining Company) include eye irritation,
- 13 skin irritation, nausea, vomiting, diarrhea, and restlessness.
- 14 Furthermore, similar materials contain a like chemical
- 15 ingredient that has been associated with causing skin cancer on
- 16 test animals. According to a recent study published in the
- 17 Journal of the American Chemical Society, air pollution from

- 1 cargo ship exhaust has been linked to the premature death of
- 2 sixty thousand people worldwide in 2002. Most of those deaths
- 3 resulted from heart and lung ailments.
- 4 A bill is currently pending in the United States Congress
- 5 (S. 1499) that would reduce air pollution from marine vessels,
- 6 including marine vessel fuels containing high amounts of sulfur.
- 7 Cruise ships generate large amounts of air pollution from
- 8 continuous burning, twenty-four hours per day and seven days a
- 9 week, as they provide power for air conditioning and electricity
- 10 to thousands of guest rooms. In effect, a cruise ship is a
- 11 virtual floating power plant.
- 12 The legislature further finds that the health of residents
- 13 in communities surrounding Nawiliwili harbor on the island of
- 14 Kauai is particularly at risk from the burning of bunker fuel by
- 15 vessels because of prevailing wind patterns and the proximity of
- 16 the surrounding communities to bunker fuel-burning vessels
- 17 operating near or moored at Nawiliwili harbor.
- 18 The purpose of this Act is to prohibit the burning of
- 19 bunker fuel by cruise ships within a five-mile radius of
- 20 Nawiliwili harbor.

""Air pollutant" has the same meaning as in the Clean Air 1 Act, 42 United States Code section 7602 (g), bunker fuel oil 2 emissions as provided in section 342B- , and any substance 3 designated as such by rules adopted under chapter 91. 4 "Source" means any property, real or personal, [which] or 5 any cruise ship or commercial passenger vessel as provided in 6 section 342B- , that emits or may emit any air pollutant." 7 SECTION 4. Statutory material to be repealed is bracketed 8 and stricken. New statutory material is underscored. 9 SECTION 5. This Act shall take effect upon its approval. 10
