

# H.B. NO. 3134

## A BILL FOR AN ACT

RELATING TO WELL CHILD FOLLOW-UP VISITS.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1           SECTION 1. The purpose of this Act is to establish a "well  
2 child" follow-up visit project as a pilot project to determine  
3 if providing a face-to-face visit with the child and family  
4 within a year after a case has been investigated and closed  
5 because the allegation of abuse or neglect was not confirmed,  
6 will decrease the possibility of additional reports of  
7 substantial abuse or neglect involving the same child and  
8 family.

9           SECTION 2. (a) There is established a "well child" follow-  
10 up visit project within the department of human services as a  
11 pilot project to provide for a "well child" visit with families  
12 who have been reported to and investigated by child welfare  
13 services, but who have not been confirmed for child abuse or  
14 neglect, pursuant to section 587-21, Hawaii Revised Statutes, to  
15 ensure the continued safety and well-being of the child, subject  
16 to the appropriation of general funds for the project.

17           (b) The "well child" follow-up project may include, but  
18 need not be limited to, conducting a "well child" follow-up visit

1 for each child in cases where physical or sexual abuse or neglect  
2 has been alleged and investigated but not confirmed after  
3 completion of the investigation.

4 (c) The "well child" visit may be conducted no earlier than  
5 six months, but within one year, after the completion of the  
6 investigation.

7 (d) The department of human services or its designated  
8 contractor shall provide "well child" follow-up visits, subject  
9 to the appropriation of general funds for this project. The  
10 department may contract with an appropriate entity to provide  
11 these services.

12 SECTION 3. The department shall submit a report on the  
13 status of the project to the legislature no later than twenty  
14 days prior to the convening of the 2010 regular session.

15 SECTION 4. There is appropriated out of the general  
16 revenues of the State of Hawaii the sum of \$1,000,000, or so much  
17 thereof as may be necessary for fiscal year 2008-2009, for the  
18 "well child" follow-up visit pilot project.

19 The sum appropriated shall be expended by the department of  
20 human services for the purposes of this Act.

**Report Title:**

Child abuse and neglect investigations; follow up visits

**Description:**

Establishes a pilot project allowing the Department to conduct well-child follow-up visits for children who have been reported but not confirmed as abused or neglected.

JUSTIFICATION SHEET

DEPARTMENT: Human Services

TITLE: A BILL FOR AN ACT RELATING TO WELL CHILD FOLLOW-UP VISITS.

PURPOSE: To establish a pilot project to provide a "well child" follow-up visit for families who have been reported and investigated by Child Welfare Services, but not confirmed for abuse or neglect.

MEANS: Enactment of a session law; appropriation.

JUSTIFICATION: The proposed pilot project will allow the department to contract for or conduct a "well child" visit with families who have been reported to and investigated by Child Welfare Services, but not confirmed for child abuse or neglect, pursuant to section 587-21, Hawaii Revised Statutes.

The proposed pilot project will allow the department to review closed cases in an effort to determine if providing a face-to-face visit with the child and family within a year after a case is closed will decrease the possibility of later cases of substantial abuse or neglect involving the same child and family.

Impact on the public: Further ensure the continued safety and well-being of children.

Impact on the department and other agencies: The department will conduct or contract for well child visits subject to the general fund appropriation authorized for this project.
