A BILL FOR AN ACT

RELATING TO AFFORDABLE HOUSING.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that self-help housing is
- 2 the lowest cost means of producing affordable housing for
- 3 very-low and low income households. Self-help housing programs
- 4 targets families who are unable to buy clean, safe housing
- 5 through conventional methods, and provides assistance to very-
- 6 low and low income households to construct their own homes. The
- 7 savings from the reduction in labor costs allows otherwise
- 8 ineligible families to own their own homes.
- 9 In Hawaii, more than one thousand one hundred homes have
- 10 been constructed using the self-help housing method for very-
- 11 low, low, and moderate income families. Additional funding,
- 12 especially in the area of technical assistance, could allow
- 13 self-help housing programs in the State to provide an average of
- 14 fifty additional units per year on the production schedules.
- 15 There is limited funding for technical assistance, which
- 16 includes funding for construction supervision, development of
- 17 construction plans, contractor payment processing, project



- 1 bidding, subcontractor monitoring, recruiting and qualifying
- 2 self-help builders, and family guidance and motivation
- 3 throughout the entire self-help housing process. The typical
- 4 technical assistance cost per self-help housing unit is \$20,000.
- 5 Although there are other sources of funding available for the
- 6 construction of homes, additional funding to cover technical
- 7 assistance costs will provide additional benefits to self-help
- 8 housing programs and allow these programs to provide more
- 9 housing opportunities to families in need.
- 10 The purpose of this Act is to establish a self-help housing
- 11 trust fund to be administered by the Hawaii housing finance and
- 12 development corporation to provide funds for technical
- 13 assistance to self-help housing programs in the State.
- 14 SECTION 2. Chapter 201H, Hawaii Revised Statutes, is
- 15 amended by adding a new subpart under part III to be
- 16 appropriately designated and to read as follows:
- 17 " . SELF-HELP HOUSING TECHNICAL ASSISTANCE TRUST FUND
- 18 §201H-A Definitions. As used in this subpart, unless a
- 19 different meaning is clearly required by the context:
- 20 "Fund" means the self-help housing technical assistance
- 21 trust fund established in this subpart.

- 1 "Self-help housing" means a model of housing production in
- 2 which purchasers reduce the cost of their homes by contributing
- 3 "sweat equity" their own labor in the construction of their
- 4 own homes.
- 5 "Technical assistance" means any assistance necessary to
- 6 carry out housing efforts by or for very low and low income
- 7 households to improve the quality or quantity of housing
- 8 available to meet their needs, including but not limited to
- 9 construction supervision and planning, contractor payment
- 10 processing and bidding, subcontractor monitoring, recruiting and
- 11 qualifying self-help housing builders, and guiding and educating
- 12 families throughout the entire self-help housing process.
- 13 §201H-B Self-help housing technical assistance trust fund.
- 14 (a) There is established the self-help housing technical
- 15 assistance trust fund to be administered by the corporation.
- 16 (b) An amount from the fund, to be set by the corporation
- 17 and authorized by the legislature, may be used for
- 18 administrative expenses incurred by the corporation in
- 19 administering the fund; provided that fund moneys shall not be
- 20 used to finance day-to-day administrative expenses of projects
- 21 allotted fund moneys.
- (c) The following may be deposited into the fund:

- 4 §201H-C Eligible organizations for funds. Eligible
- 5 organizations for funds shall be limited to tax exempt
- 6 charitable organizations under the Internal Revenue Code section
- 7 501(c)(3) in accordance with rules adopted by the corporation
- 8 pursuant to chapter 91.
- 9 §201H-D Eligible self-help housing projects. (a) Self-
- 10 help housing projects eligible for technical assistance funding
- 11 shall be based solely on the readiness to use moneys available
- 12 in the fund, such as whether the project site is ready for house
- 13 construction or the track record of the eligible self-help
- 14 housing organization in producing self-help housing units.
- 15 (b) Technical assistance funding for self-help housing
- 16 projects shall be limited to the projects targeted to very low,
- 17 low, and medium income families. For purposes of this subpart,
- 18 the applicable median family income shall be the median family
- 19 income for the county or standard metropolitan statistical area
- 20 in which the project is located as determined by the United
- 21 States Department of Housing and Urban Development, as adjusted
- 22 from time to time.

- 1 (c) The corporation may include other eligibility criteria
- 2 as it deems necessary to carry out the purposes of this subpart.
- 3 §201H-E Additional powers. The powers conferred upon the
- 4 corporation by this subpart shall be in addition and
- 5 supplemental to the powers conferred by any other law, and
- 6 nothing in this subpart shall be construed as limiting any
- 7 powers, rights, privileges, or immunities conferred."
- 8 SECTION 3. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$ or so
- 10 much thereof as may be necessary for fiscal year 2008-2009 to be
- 11 deposited into the self-help housing technical assistance trust
- 12 fund to be used to provide additional funding for technical
- 13 assistance costs generated by self-help housing projects in the
- 14 State.
- 15 SECTION 4. There is appropriated out of the self-help
- 16 housing technical assistance trust fund the sum of \$
- 17 or so much thereof as may be necessary for fiscal year 2008-2009
- 18 to be used to provide additional funding for technical
- 19 assistance costs generated by self-help housing projects in the
- 20 State.

- 1 The sum appropriated shall be expended by the Hawaii
- 2 housing finance and development corporation for the purposes of
- 3 this Act.

Description:

Establishes a self-help housing technical assistance trust fund under the Hawaii housing finance and development corporation to provide funding for technical assistance costs generated by self-help housing projects. Makes an appropriation into the fund and authorizes the moneys to be expended to carry out the purposes of the fund.
