A BILL FOR AN ACT

RELATING TO VETERAN BURIAL GRANTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECTION 1. The legislature finds that a Filipino veteran
2	of the New Filipino Scouts who enlisted between October 6, 1945,
3	and June 30, 1947, who died after June 30, 1994, and who was, at
4	the time of the veteran's death, a United States citizen and a
5	resident of the State of Hawaii, is entitled to receive a burial
6	grant from the state office of veterans' services to pay for the
7	cost of:
8	(1) Providing funeral and burial services for the deceased
9	veteran; and
10	(2) Transporting the remains of the deceased veteran to
11	the Philippines.
12	To qualify for this burial grant, however, the Filipino
13	veteran's survivor or an interested party must produce an
14	itemized paid invoice showing the specific services rendered on
15	behalf of the deceased veteran. Because of the tremendous costs
16	required to procure funeral and burial services, as well as the
17	cost of transportation to the Philippines, some World War II
18	Filipino veterans, including the families and friends of these HB831 HD2 HMS 2007-2493

- 1 veterans, cannot afford to pay for these activities in advance.
- 2 Consequently, some World War II Filipino veterans will not be
- 3 able to qualify for these burial grants from the office of
- 4 veterans' services because they cannot pay upfront costs
- 5 associated with funeral, burial, and transportation services to
- 6 be reimbursed at a later time. Because of these financial
- 7 constraints, the bodies of some deceased veterans could not be
- 8 properly buried until the deceased veteran's survivor or
- 9 interested parties raised the necessary funds to pay the
- 10 mortuary for funeral and other related services.
- 11 The legislature further finds that under the Veterans
- 12 Benefits and Health Care Improvement Act of 2000 (Public Law
- 13 106-419), many World War II Filipino veterans previously
- 14 eligible to participate in the state office of veterans'
- 15 services program regarding transportation of remains to the
- 16 Philippines are now eligible to be interred in state and federal
- 17 veterans' cemeteries. Therefore, in fairness to other veterans'
- 18 survivors who are not offered reimbursement for such
- 19 transportation needs, the payments made under this Act are
- 20 properly limited to only those veterans of the New Filipino
- 21 Scouts who are not eligible for interment in state and federal

- 1 veterans cemeteries under the Veterans Benefits and Health Care
- 2 Improvement Act of 2000.
- 3 This Act requires the office of veterans' services to
- 4 provide an alternative to the procedures currently specified in
- 5 the rules of the office of veterans' services, which only apply
- 6 in situations where a deceased Filipino veteran's survivor or an
- 7 interested party has already paid for services rendered on
- 8 behalf of the deceased veteran, or in situations where the
- 9 deceased veteran may have purchased a pre-paid funeral and
- 10 burial plan.
- 11 The purpose of this Act, through the veterans' burial grant
- 12 program, is to pay directly to a mortuary or crematory the cost
- 13 of:
- 14 (1) Providing funeral and burial services at the request
- of a qualifying deceased Filipino veteran's survivor
- or an interested party; and
- 17 (2) Transporting the veteran's remains to the Philippines,
- 18 upon the submission of a contract for services on behalf of the
- 19 deceased veteran and an itemized unpaid invoice. The amount
- 20 paid for funeral and burial services and transportation costs
- 21 shall not exceed \$ per person.

1	SECTION 2. Chapter 363, Hawaii Revised Statutes, is
2	amended by adding a new section to be appropriately designated
3	and to read as follows:
4	"§363- Disbursement of World War II Filipino veterans
5	burial grant funds. (a) At the request of a deceased World War
6	II New Filipino Scout's survivor or an interested party, the
7	office of veterans' services shall receive, review, and, as
8	appropriate, approve requests for payments for:
9	(1) Providing funeral and burial services for a New
10	Filipino Scout who died after June 30, 1994; and
11	(2) Transporting the remains of a New Filipino Scout to
12	the Philippines.
13	(b) The office of veterans' services shall establish the
14	amount of burial grant funds that may be disbursed on behalf of
15	a New Filipino Scout; provided that the amount shall not exceed
16	\$ per person.
17	(c) The office of veterans' services shall not expend more
18	than the amount appropriated for the fiscal year to provide
19	burial grants for deceased New Filipino Scouts.
20	(d) Specific eligibility criteria, application and appeal
21	procedures, service choices, and invoicing arrangements shall be
22	established by the office of veterans' services.

SECTION 3.
