
HOUSE CONCURRENT RESOLUTION

REQUESTING THE ESTABLISHMENT OF A RELATIONSHIP BETWEEN THE STATE
OF HAWAII AND THE ISLANDS OF POLYNESIA.

1 WHEREAS, the State of Hawaii is actively seeking to expand
2 its international ties and has an abiding interest in developing
3 goodwill, friendship, and economic relations between the people
4 of Hawaii and the people of the many nations and territories
5 comprising Polynesia; and

7 WHEREAS, as part of its effort to achieve this goal, Hawaii
8 has established a number of sister-state agreements with
9 provinces in the Pacific region; and

11 WHEREAS, historical precedent exists which exemplify a
12 common desire to maintain a close cultural, commercial, and
13 financial bridge between Polynesians living in Hawaii and their
14 relatives, friends, and business counterparts in the islands of
15 Polynesia, and the establishment of sister-state relations
16 between the State of Hawaii and Polynesia would help reinforce
17 and cement this common bridge; and

19 WHEREAS, the geographic location of Hawaii presents an
20 outstanding opportunity to promote global connectivity among the
21 islands of Polynesia for the purposes of proliferating
22 meaningful and mutually rewarding international friendships,
23 understanding between cultures, economic and social vitality,
24 scientific and technological advancement, and enhanced regional
25 security; now, therefore,

27 BE IT RESOLVED by the House of Representatives of the
28 Twenty-fourth Legislature of the State of Hawaii, Regular
29 Session of 2008, the Senate concurring, that the Governor is
30 requested to take action to establish a relationship between
31 Hawaii and the islands of Polynesia, including the following:

29 establishing the relationship and to be involved in its
30 formalization; and

38 President of the Federated States of Micronesia, Prime Minister
39 of New Zealand, Governor General of the Independent State of
40 Papua New Guinea, Governor of the Pitcairn Islands, President of
41 Fiji, Prime Minister of Samoa, King of Tonga, Governor General
42 of Tuvalu, and President of the Territorial Assembly of Wallis
43 and Futuna.
