
HOUSE CONCURRENT RESOLUTION

URGING THE DEPARTMENT OF EDUCATION TO STUDY THE FEASIBILITY OF
INTEGRATING REHABILITATION PROGRAMS FOR STUDENTS WITH ANGER
PROBLEMS.

1 WHEREAS, today's world of modern technology is capable of
2 exposing us to events occurring across the globe, such as the
3 Iraq war, and we are constantly reminded that the issues of
4 aggression and antagonism remain a huge challenge for people to
5 overcome; and

6
7 WHEREAS, the violence that exists within our own country is
8 made sadly evident by the actions of our youth, including
9 shootings and reports of violence within colleges, high schools,
10 and even in middle and elementary schools; and

11
12 WHEREAS, Hawaii's unique island location serves as a bridge
13 between the East and the West, bringing many different cultures
14 together to create a wonderfully diverse place to live, but such
15 diversity can also lead to tensions; and

16
17 WHEREAS, there have been instances of hostilities within
18 our own schools involving firearms on campus, extreme hazing,
19 and psychological abuse among peers; and

20
21 WHEREAS, currently, Hawaii public school students who
22 engage in acts of violence are not given the tools they need to
23 change their behavior because the most prevalent method of
24 dealing with such behavior is to remove the student from school
25 instead of teaching the student how to properly manage feelings
26 of anger; and

27
28 WHEREAS, as a result of Act 205, Session Laws of Hawaii
29 2006, programs have been developed to assist students who have
30 used drugs or alcohol, by screening and evaluating the student



1 to determine if they have substance abuse problems and identify
2 the underlying issues that have led them to such behavior; and

4 WHEREAS, if a student is diagnosed as having a substance
5 abuse problem, they are placed in a program with a specialist
6 who helps them overcome their addiction; and
7

8 WHEREAS, a similar intervention and rehabilitation program
9 should be put into place to provide students with anger
10 management issues with the help they need to manage their
11 feelings of frustration and antagonism learn more productive
12 outlets for such feelings and avoid acting out in violence; now,
13 therefore,

15 BE IT RESOLVED by the House of Representatives of the
16 Twenty-fourth Legislature of the State of Hawaii, Regular
17 Session of 2008, the Senate concurring, that the Department of
18 Education (DOE) is requested to study the feasibility of
19 establishing an anger management program modeled after
20 substance abuse programs to provide students who commit acts of
21 violence or harassment at their school with the tools they need
22 to change their behavior; and

24 BE IT FURTHER RESOLVED that DOE is requested to submit a
25 report to the Legislature, no later than 20 days prior to
26 convening of the Regular Session of 2009, on the progress of its
27 study, including:

- 29 (1) Proposals for DOE anger management programs; and
