A BILL FOR AN ACT

RELATING TO LIABILITY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that the statutes 2 providing state and county immunity on certain public lands have 3 proven to be beneficial to the state and county governments as 4 well as the general public. The liability protections have 5 reduced the exposure of the state and county governments to 6 substantial damages and, as a result, allowed the state and 7 county governments to keep recreational areas with potentially 8 dangerous conditions open to the public. Furthermore, the 9 warning signage required by the statutes has promoted public 10 safety by informing users of the recreational areas of 11 potentially dangerous conditions.

12 The purpose of this Act is to extend the sunset dates of 13 three statutes that provide the state and county governments 14 with liability protection for public use of certain state or 15 county recreational areas.
