# A BILL FOR AN ACT

RELATING TO THE HAWAII HEALTH SYSTEMS CORPORATION.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. The legislature finds that the cost of medical 1 malpractice and hospital professional and general liability 2 coverage continues to rise and that stability in risk financing 3 is needed for the Hawaii health systems corporation and the 4 physicians serving this entity. The escalating costs of 5 premiums, lack of insurers providing coverage in Hawaii, 6 decreased limits of available coverage, and coverage 7 restrictions, make it important to establish a captive insurance 8 company to insure and control exposure to the liability risks of 9 10 the aforementioned entity.

11 The purpose of this Act is to authorize and provide initial 12 funding for the establishment of a domestic captive insurance 13 company five year pilot project by the Hawaii health systems 14 corporation to provide medical malpractice and hospital 15 professional and general liability coverage for the corporation 16 and the physicians serving the entity.
