### A BILL FOR AN ACT

RELATING TO HOUSING.

### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	PART I. FINDINGS AND PURPOSE
2	SECTION 1. The legislature finds that the homeless and
3	affordable housing crises continue to be one of the State's most
4	significant and challenging social problems. The most recent
5	estimate of the total number of homeless persons in the State is
6	six thousand twenty nine on any given day. In addition, the
7	Hawaii Homeless Point-in-Time Study of 2003 found that over four
8	thousand of these homeless persons are unsheltered. This is
9	indicative of the limited shelter space available in the State.
10	Also troubling is the fact that a staggering thirty-seven
11	per cent of the unsheltered homeless are individuals of Hawaiian
12	or part-Hawaiian ancestry. Equally troubling is the fact that
13	on any given day, there are eight hundred thirty-eight homeless
14	children in the State.
15	None of these numbers reflect the number of people who are
16	considered hidden homeless or those who are at-risk of
17	homelessness.

1	The	legislature recognizes that meaningful solutions to
2	Hawaii's	housing and homeless problem must be found.
3	The	purpose of this Act is to:
4	(1)	Provide funding for various homeless shelters and
5		transitional housing programs and services;
6	(2)	Require the Hawaii finance and development corporation
7		to create an affordable housing inventory registry to
8		identify state and county lands that may be used for
9		affordable housing;
10	(3)	Extend the sunset date for the allocation of fifty per
11		cent of conveyance tax revenues to the rental housing
12		trust fund to June 30, 2009; and
13	(4)	Provide funding for various affordable and public
14		housing programs.
15		PART II. THE HOMELESS
16	SECT	ION 2. There is appropriated out of the general
17	revenues	of the State of Hawaii the sum of \$ , or so
18	much ther	eof as may be necessary for the fiscal year 2007-2008,
19	for homel	ess facilities, emergency shelters, and transitional
20	shelters,	as defined by section 356D-121, Hawaii Revised
21	Statutes.	

- The sum appropriated shall be expended by the Hawaii publichousing authority for the purposes of this section.
- 3 SECTION 3. There is appropriated out of the general
- 4 revenues of the State of Hawaii the sum of \$ , or so
- 5 much thereof as may be necessary for fiscal year 2007-2008, and
- 6 the same sum, or so much thereof as may be necessary for fiscal
- 7 year 2008-2009, to provider agencies, as defined by section
- 8 356D-121, Hawaii Revised Statutes, who offer outreach and/or
- 9 support services to unsheltered homeless, at risk homeless, and
- 10 those residing in homeless facilities, including emergency
- 11 shelters and transitional shelters.
- 12 The sums appropriated shall be expended by the department
- 13 of human services for the purposes of this section.
- 14 PART III. AFFORDABLE AND PUBLIC HOUSING
- 15 SECTION 4. Section 201H-6, Hawaii Revised Statutes, is
- 16 amended to read as follows:
- "[+] \$201H-6[+] Housing advocacy and information system.
- 18 (a) The corporation, with the assistance of other agencies of
- 19 the State and counties with related responsibilities, shall
- 20 develop and maintain a housing advocacy and information system
- 21 to aid the corporation in meeting the needs and demands of
- 22 housing consumers.



- 1 (b) In establishing and maintaining the housing advocacy
- 2 and information system, the corporation shall conduct market
- 3 studies, engage in community outreach, and solicit
- 4 recommendations from and statistics and research developed by
- 5 agencies of the United States, the State, the counties, private
- 6 research organizations, nonprofit community groups, trade
- 7 associations, including those of the construction and real
- 8 estate industries, departments, individuals at the University of
- 9 Hawaii, and housing consumers.
- 10 (c) The corporation shall analyze the information received
- 11 and make recommendations to the appropriate agencies and
- 12 developers.
- 13 (d) The corporation, through the housing advocacy and
- 14 information system, shall act as a clearinghouse for information
- 15 relating to housing conditions, needs, supply, demand,
- 16 characteristics, developments, trends in federal housing
- 17 programs, and housing laws, ordinances, rules, and regulations.
- (e) The housing advocacy and information system may be
- 19 used by housing researchers, planners, administrators, and
- 20 developers and shall be coordinated with other housing research
- 21 efforts. The corporation shall maintain a current supply of

- 1 information, including means to gather new information through
- 2 surveys, contracted research, and investigations.
- 3 (f) The corporation, through the housing advocacy and
- 4 information system, and with the assistance of other agencies of
- 5 the State and counties with related responsibilities, shall
- 6 develop and maintain an affordable housing inventory registry to
- 7 identify state and county lands that may be developed for
- 8 affordable housing, as defined in section 201H-57(b)."
- 9 SECTION 5. Act 100, Session Laws of Hawaii 2006, is
- 10 amended by amending section 30 to read as follows:
- 11 "SECTION 30. This Act shall take effect on July 1, 2006;
- 12 provided that on June 30, [2007,] 2009, section 21 shall be
- 13 repealed and section 247-7, Hawaii Revised Statutes, shall be
- 14 reenacted in the form in which it read on the day before the
- 15 approval of this Act."
- 16 SECTION 6. There is appropriated out of the general
- 17 revenues of the State of Hawaii the sum of \$ , or so
- 18 much thereof as may be necessary for fiscal year 2007-2008, and
- 19 the same sum, or so much thereof as may be necessary for fiscal
- 20 year 2008-2009, to the rental housing trust fund for the
- 21 planning, development, and construction of affordable housing in
- 22 cooperation with private and nonprofit developers.



- 1 The sums appropriated shall be expended by the Hawaii
- 2 housing finance and development corporation for the purposes of
- 3 this section.
- 4 SECTION 7. The director of finance is authorized to issue
- 5 general obligation bonds in the sum of \$ , or so much
- 6 thereof as may be necessary, and the same sum, or so much
- 7 thereof as may be necessary, is appropriated for fiscal year
- 8 2007-2008, to the dwelling unit revolving fund for the planning,
- 9 development, and construction of four thousand affordable
- 10 housing units in cooperation with private developers.
- 11 The sum appropriated shall be expended by the Hawaii
- 12 housing finance and development corporation for the purposes of
- 13 this section.
- 14 SECTION 8. There is appropriated out of the general
- 15 revenues of the State of Hawaii the sum of \$ , or so
- 16 much thereof as may be necessary for fiscal year 2007-2008, for
- 17 the repair and maintenance of existing federal and state public
- 18 housing buildings.
- 19 The sum appropriated shall be expended by the Hawaii public
- 20 housing authority.
- 21 SECTION 9. The director of finance is authorized to issue
- 22 general obligation bonds in the sum of \$ , or so much
