## A BILL FOR AN ACT

RELATING TO EDUCATION.

## BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1		PART I
2		EDUCATIONAL WORKFORCE WORKING GROUP
3	SECTION 1	. (a) There is established an educational workforce
4	working g	roup that shall convene no later than August 1, 2007,
5	to examin	e and address the following issues:
6	(1)	How well the workforce needs of Hawaii are currently
7		being met;
8	(2)	How prepared the State is to meet the workforce needs
9		of the future;
10	(3)	What recommendations can be made to improve Hawaii's
11		educational system to fulfill the workforce needs of
12		the future;
13	(4)	What is the current relationship between public
14		schools and emerging industries;
15	(5)	What percentage of high school students participate in
16		any form of vocational or professional training
17		outside of the school setting;

1	(6)	What aspects of high school curriculum, standards, and
2		assessment strategies have a direct relationship to
3		the state's future workforce needs;

- (7) What are the challenges or impediments to creating a more direct relationship between schools and economy driving industries of the state;
- (8) How might autonomous schools-within-schools, magnet schools, specialized schools, and charter schools be better used to create more direct links between high schools and economy driving industries of the state; and
- (9) How might the size of public schools, the distribution of discretionary funding, the decentralized authority of school community councils or charter school local school boards, and other organizational reforms be better used to satisfy the workforce development needs of the information and technology age.
- (b) The educational workforce working group shall submit a report on its findings and recommendations regarding the issues set forth in subsection (a), including any recommendations and proposed legislation, to the legislature no later than twenty days prior to the convening of the regular session of 2008.

- 14 SECTION 3. The department of education shall include
- 15 within its strategic plan, plans to ensure optimal use of
- 16 technology for administration, data collection, and data sharing
- 17 related to educational and workforce needs, and plans to ensure
- 18 personalized student education plans will provide a direct link
- 19 to economic and workforce needs.
- The department of education shall submit a report
- 21 containing its five-year plan to the legislature no later than



1 twenty days prior to the convening of the regular session of 2008. 2 3 SECTION 4. The University of Hawaii shall prepare a report 4 detailing: 5 (1)The current activities on each of its campuses to 6 prepare students with the skills and knowledge needed 7 to successfully enter and progress in the Hawaii 8 workforce: 9 (2) The University of Hawaii's current plans to increase 10 the percentage of Hawaii high school graduates who 11 continue their education by enrolling in a University 12 of Hawaii campus and to increase the percentage of 13 students who earn degrees or certificates within one 14 hundred fifty per cent of the planned length of the 15 degree, particularly in fields where the State is 16 experiencing shortages of qualified employees; and (3) Recommendations about additional steps the State needs 17 18 to consider implementing to increase the number of 19 qualified workers in the state.

The University of Hawaii shall submit a report on the foregoing to the legislature no later than twenty days prior to the convening of the regular session of 2008.

1 SECTION 5. (a) There is appropriated out of the general revenues of the State of Hawaii the sum of \$ 2 much thereof as may be necessary for fiscal year 2007-2008, and 3 the same sum, or so much thereof as may be necessary for fiscal 4 year 2008-2009, for 2.0 (FTE) workforce development liaison 5 6 positions and 1.0 (FTE) support staff position within the department of education to assist the department of education in 7 8 coordinating workforce development efforts with the various 9 departments, agencies, businesses, and organizations, including 10 the University of Hawaii and public school academies, within the state to provide students with: 11 Career exploration, awareness, and mentoring; 12 (1)Access to unpaid and paid internships and experiential 13 (2) 14 learning opportunities; and Job placement assistance; 15 (3)provided that the duties of the workforce development liaisons 16 shall be divided into public sector and private sector 17 18 relationships. The public sector liaison shall be responsible 19 for coordinating workforce development efforts between the department of education and any department or agency of the 20 State, the counties, or any political subdivisions thereof, and 21 22 the private sector liaison shall be responsible for coordinating



1 workforce development efforts between the department of education and businesses, nonprofit organizations, and other 2 3 private sector organizations. 4 (b) The workforce development liaisons shall also be 5 responsible for: 6 (1)Identifying future workforce need areas, such as 7 nursing, teaching, science and technology, and 8 agribusiness; (2) Working to establish new academies to support growth 9 in workforce need areas; 10 Interfacing with the business community to determine 11 (3) 12 what skill sets are necessary and to create mutually 13 beneficial relationships between the schools or 14 academies and businesses, including the development of 15 paid internships and facilitating job opportunities; 16 and 17 (4) Assisting the public schools and the academies with curriculum integration and other department of 18 education functions. 19

The sums appropriated shall be expended by the department

of education for the purposes of this part.

3	SECTION 6. Section 202-5, Hawaii Revised Statutes, is
4	amended to read as follows:
5	"§202-5 Organizational relationships. The workforce
6	development council is placed within the [department of labor
7	and industrial relations department of business, economic
8	development, and tourism for administrative purposes and shall
9	act in an advisory capacity to the governor."
10	SECTION 7. Statutory material to be repealed is bracketed
11	and stricken. New statutory material is underscored.
12	SECTION 8. This Act shall take effect on July 1, 2050.

## Report Title:

Education; Workforce Development

## Description:

Establishes and appropriates funds for an educational workforce working group under DBEDT, to examine and address issues workforce and workforce-related education issues. Requires DOE to include in its strategic plan, plans for workforce-related needs. Requires UH to submit a report to the Legislature on its workforce development efforts. Appropriates funds for positions to assist DOE with its workforce development efforts. Transfers Workforce Development Council from DLIR to DBEDT. (SB1931 HD2)
