BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. Section 346-53, Hawaii Revised Statutes, is 2 amended by amending subsection (c) to read as follows: 3 The director, pursuant to chapter 91, shall determine the rate of payment for domiciliary care, including care 4 provided in licensed developmental disabilities domiciliary 5 6 homes, community care foster family homes, and certified adult foster homes, to be provided to recipients who are eligible 7 [cither] for Federal Supplementary Security Income[7] or public 8 assistance [in accordance with state standards], or both. 9 10 director shall provide for level of care payment as follows: 11 For [those] adult residential care homes classified as (1)facility type I, licensed developmental disabilities 12 domiciliary homes as defined under section 321-15.9, 13 community care foster family homes as defined under 14 15 section 346-331, and certified adult foster homes as defined under section 321-11.2, the state supplemental 16 payment shall not exceed [\$621.90; and] \$641.90; 17

1	(2) For [those] adult residential care homes classified as
2	facility type II, the state supplemental payment shall
3	not exceed [\$729.90.] \$749.90; and
4	(3) For skilled nursing facilities and intermediate
5	facilities, the state supplemental payment shall not
6	exceed \$20.
7	\$50 of the state supplemental payment shall be retained by the
8	recipient for the recipient's personal use, except for a
9	recipient who is a resident of a skilled nursing facility or
10	intermediate facility who shall retain \$20 of the state
11	supplemental payment.
12	If the operator does not provide the quality of care
13	consistent with the needs of the individual to the satisfaction
14	of the department, the department may remove the recipient to
15	another facility.
16	The department shall handle abusive practices under this
17	section in accordance with chapter 91.
18	Nothing in this subsection shall allow the director to
19	remove a recipient from an adult residential care home or other
20	similar institution if the recipient does not desire to be
21	removed and the operator is agreeable to the recipient
