A BILL FOR AN ACT

RELATING TO DENTISTS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 448-1, Hawaii Revised Statutes, is
 amended to read as follows:

"§448-1 Dentistry defined; exempted practices. A person 3 practices dentistry, within the meaning of this chapter, who 4 represents oneself as being able to diagnose, treat, operate or 5 6 prescribe for any disease, pain, injury, deficiency, deformity, 7 or physical condition of the human teeth, alveolar process, gums, or jaw, or who offers or undertakes by any means or 8 9 methods to diagnose, treat, operate or prescribe for any 10 disease, pain, injury, deficiency, deformity, or physical 11 condition of the same, or to take impressions of the teeth or 12 jaws; or who owns, maintains, or operates an office for the 13 practice of dentistry; or who engages in any of the practices included in the curricula of recognized and approved dental 14 15 schools or colleges. Dentistry includes that part of health care concerned with the diagnosis, prevention, and treatment of 16 17 diseases of the teeth, oral cavity, and associated structures

2 fact that a person uses any dental degree, or designation, or
3 any card, device, directory, poster, sign, or other media
4 whereby one represents oneself to be a dentist, shall be prima

7 The following practices, acts, and operations, however, are8 exempt from the operation of this chapter:

9 (1) The rendering of dental relief in emergency cases in
10 the practice of one's profession by a physician or

12 laws of this State, unless one undertakes to reproduce
13 or reproduces lost parts of the human teeth in the
14 mouth or to restore or replace in the human mouth lost

Dental Association or component parts thereof, alumni 1 2 meetings of dental colleges, or any other like dental organizations, while appearing as clinicians; 3 The use of roentgen and other rays for making 4 (4)radiograms or similar records of dental or oral 5 6 tissues; [and] The making of artificial restorations, substitutes, 7 (5)appliances, or materials for the correction of 8 9 disease, loss, deformity, malposition, dislocation, 10 fracture, injury to the jaws, teeth, lips, gums, 11 cheeks, palate, or associated tissues, or parts, upon orders, prescription, casts, models, or from 12 impressions furnished by a Hawaii licensed dentist[-]; 13 14 and (6) The ownership and management of a dental practice by 15 the executor or administrator of a dentist's estate or 16 the legal guardian or authorized representative of a 17 dentist, where the licensed dentist has died or is 18 19 incapacitated, for the purpose of winding down, transferring, or selling the practice, for a period 20 21 not to exceed one year from the time of death or from 22 the date the dentist is declared incapacitated;


