A BILL FOR AN ACT

RELATING TO MENTAL HEALTH COUNSELORS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

 SECTION 1. Act 14, Session Laws of Hawaii 2006 (Act 14),
 was enacted to amend the definition of the "practice of mental health counseling" by clarifying that professional counseling
 services are determined by the specialized education, training,
 and experience that a practitioner has completed. In addition,
 Act 14 sets terms and conditions for interns and post-graduate
 work.

8 The purpose of this Act is to clarify the requirements for 9 mental health counselor licensure by establishing that those 10 persons who applied to the department after July 1, 2005, and 11 graduated from an accredited program before July 1, 2007, may be 12 eligible for licensure.

13 SECTION 2. Section 453D-7, Hawaii Revised Statutes, is14 amended to read as follows:

15 "§453D-7 Application for licensure as a mental health
16 counselor. (a) Any person who applies to the department after
17 July 1, 2005, and who graduated after July 1, 2007, from an

1 accredited program as specified in paragraph (1), shall be 2 issued a license by the department if the applicant provides 3 satisfactory evidence to the department that the applicant is qualified for licensure pursuant to the requirements of this 4 5 chapter and meets the following qualifications:

6 A master's degree or doctoral degree from an (1)7 accredited educational institution in counseling or in an allied field related to the practice of mental 8 9 health counseling that includes or is supplemented by graduate level course work in counseling comprising a 10 minimum of forty-eight semester hours or seventy-two 11 12 guarter hours in the following course areas, with a 13 minimum of three semester hours or five quarter hours 14 in each course area as indicated below: 15 Human growth and development, including but not (A) limited to the study of life span development, 16 17 strategies to facilitate that development and 18 transitions, theories of learning and personality development, and human behavior to include

crisis, disabilities, addictive behavior, and environmental factors;



Mental Health Counselors; Licensing

Description:

Amends the mental health counselor licensure application date to include counselors who have completed or are in the process of completing the requirements for licensure before July 1, 2007. Repeals the sunset date on mental health counselor licensure.
