A BILL FOR AN ACT

RELATING TO EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that envisioning and
- 2 planning for Hawaii in the new century is complex and
- 3 multifaceted. The education of the citizenry, including early
- 4 childhood through K-12 schooling to college and career and work
- 5 force training, has and will always be of critical importance.
- 6 The legislature believes that the vision and plans for education
- 7 and schools at mid-century cannot be initiated too early. The
- 8 Hawaii P-20 Initiative is a consortium of public and private
- 9 educators, governmental officials, and community leaders working
- 10 together to improve learner achievement in Hawaii.
- 11 The purpose of this Act is to provide the impetus for
- 12 developing the vision and plans for education in Hawaii for the
- 13 coming century by funding the Hawaii P-20 Initiative to develop
- 14 and initiate plans for education in Hawaii in the new century.
- 15 SECTION 2. The Council of Hawaii P-20 Initiative shall
- 16 develop and initiate plans for education in Hawaii in the new
- 17 century, including identifying contributors and planners,

- 1 creating a vision, goals, objectives and timelines, and
- 2 organizing meetings and electronic communication. The general
- 3 goals of the effort will be to ensure an engaged, responsible,
- 4 and productive citizenry in Hawaii in the new century that is
- 5 the expected result of an education system and schools that are
- 6 coordinated and articulated from earliest teaching to career and
- 7 work force preparation and to promote lifelong learning.
- 8 SECTION 3. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$50,000, or so much
- 10 thereof as may be necessary for fiscal year 2007-2008, and the
- 11 same sum, or so much thereof as may be necessary for fiscal year
- 12 2008-2009, to the Hawaii P-20 Initiative for the initiation and
- 13 development of plans for education in Hawaii in the new century.
- 14 The sums appropriated shall be expended by the Hawaii P-20
- 15 Initiative Council for the purposes of this Act.
- 16 SECTION 4. The Council of the Hawaii P-20 Initiative shall
- 17 prepare progress reports for the legislature no later than the
- 18 last day of each calendar year for which it is funded by this
- 19 and future Acts.
- 20 SECTION 5. This Act shall take effect on July 1, 2007.
