A BILL FOR AN ACT

RELATING TO DEVELOPMENTAL DISABILITIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Section 333F-2, Hawaii Revised Statutes, sets
- 2 forth the supports and services the department of health
- 3 administers. These include the administration of early
- 4 identification of persons with developmental disabilities or
- 5 mental retardation and critical development, planning, and
- 6 implementation in coordination with other federal, state, and
- 7 county agencies of service programs. It establishes a continuum
- 8 of comprehensive services and residential alternatives in the
- 9 community to allow persons with developmental disabilities or
- 10 mental retardation to live in the least restrictive,
- 11 individually appropriate environment.
- 12 The purpose of this Act is to extend the repeal date of Act
- 13 303, Session Laws of Hawaii 2006, from June 30, 2008, to
- 14 June 30, 2009, in order to extend the repeal date of amendments
- 15 made to section 333F-2(c)(9), Hawaii Revised Statutes, and to
- 16 require a report from the department of health, state council on
- 17 developmental disabilities.
