BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

2	SECTION 1. The purpose of this part is to promote fiscal
3	accountability with regard to agricultural land lease agreements
4	between the State and lessees by allowing the agribusiness
5	development corporation to contract with financial institutions
6	as lease income collection agents.

The plans shall include a proposal for the 1 2 organization of the enterprise, a marketing information and 3 strategy, the impact on existing agricultural operations throughout the State, and a recommendation for the construction, 4 reconstruction, rehabilitation, improvement, alteration, or 5 6 repair of any infrastructure or accessory facilities in 7 connection with any project. 8 The corporation may enter into cooperative agreements (C) 9 with coordinating entrepreneurs or public agencies when the 10 powers, services, and capabilities of the persons or agencies 11 are deemed necessary and appropriate for the development and 12 implementation of the business and agricultural development 13 plans. 14 The corporation may purchase, accept, and maintain (d) permanent conservation easements, or transfer these easements to 15 a qualified land trust in accordance with the Natural Resources 16 Conservation Service farm and ranch lands protection program. 17 (e) Notwithstanding any provision of this chapter to the 18 19 contrary, when leasing corporation-controlled agricultural land, 20 the corporation may contract with a financial institution 21 chartered under chapter 412 or a federal financial institution, 22 as defined under section 412:1-109, that is transacting business SB837 SD2 LRB 07-3071.doc

21	article XI, sections 3 and 10 of the state constitution,

promotion of farm ownership and diversified agriculture, by 1 2 establishing a process to ensure that certain lands in the Kunia area on the island of Oahu: 3 4 (1)Remain available for agricultural use; Are properly managed so as to ensure continued 5 (2)6 economic viability while used for agriculture; and Are managed in a manner that is sensitive to and 7 (3)consistent with the needs of farmers in the Kunia 8 9 area. 10 The legislature finds that this Act is in accordance with 11 article XI, sections 3 and 10 of the state constitution, is in the public interest, and will preserve agricultural activities 12 in the area and a lifestyle that benefits the Kunia community 13 14 and the community at large. SECTION 6. (a) The agribusiness development corporation 15 16 may purchase the agricultural lands located in the Kunia area of the island of Oahu and owned by private entities. 17 18 (b) The agribusiness development corporation may purchase the lands with a combination of revenues derived through the 19 issuance of revenue bonds pursuant to section 163D-9, Hawaii 20 Revised Statutes, and moneys appropriated under section 8 of 21 22 this Act. 

1 The agribusiness development corporation shall submit (C) 2 to the legislature a progress report on its actions to obtain 3 the Kunia agricultural lands not later than twenty days prior to 4 the convening of the 2008 regular session. 5 SECTION 7. Section 163D-9, Hawaii Revised Statutes, is 6 amended by amending subsection (a) to read as follows: 7 "(a) The corporation, with the approval of the governor, may issue, from time to time, revenue bonds in amounts not 8 exceeding the total amount of bonds authorized to be issued by 9 10 the legislature for the purpose of constructing, acquiring, 11 remodeling, furnishing, and equipping any project facility, 12 including the acquisition of the site thereof [-,], or acquiring 13 agricultural lands through purchase in order to sustain and

14 preserve viable agricultural enterprises within a contiguous 15 geographic area."

SECTION 8. There is appropriated out of the general revenues of the State of Hawaii the sum of \$, or so much thereof as may be necessary for fiscal year 2007-2008, for purchasing agricultural lands owned by private entities in Kunia on the island of Oahu.

21 The sum appropriated shall be expended by the agribusiness22 development corporation for the purposes of this Act.

Authorizes the agribusiness development corporation to issue revenue bonds to purchase agricultural land in Kunia from private entities. Appropriates funds to purchase the lands. Enables the agribusiness development corporation to contract with banks to provide lease management services. Allows corporation to lease agricultural lands in Kunia for up to 55 years. (SD2)
