A BILL FOR AN ACT

RELATING TO NATURAL DISASTER PREPAREDNESS IN HEALTH CARE FACILITIES.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that the devastating
- 2 effects of Hurricane Katrina revealed severe shortcomings of the
- 3 health care system serving the residents of the Gulf Coast. And
- 4 while the earthquake that shook Hawaii on October 15, 2006, did
- 5 not cause widespread severe damage, it did underscore the need
- 6 to assess the ability of our health care facilities to withstand
- 7 natural disasters.
- 8 The Office of Domestic Preparedness within the Office of
- 9 Homeland Security issued a directive to each state requiring
- 10 them to assess their ability to evacuate and shelter residents
- 11 in the event of a disaster. Of particular concern are the
- 12 special populations served by hospitals and long term care
- 13 facilities.
- 14 Hurricane Katrina demonstrated that smaller residential
- 15 health care facilities on the Gulf Coast, such as nursing homes,
- 16 were not constructed to withstand strong winds. Hawaii is in a
- 17 similar situation. Discussions with nursing home executives

- 1 revealed that many were uncertain whether their facilities could
 2 resist the effects of a hurricane, and most felt they would be
- 3 compelled to evacuate their residents because of this
- 4 uncertainty. However, the capacity of shelters that are
- 5 specially designed for nursing home residents is insufficient.
- 6 Although state officials are currently working to establish
- 7 special needs shelters and to improve evacuation procedures,
- 8 they concede that the number of actual and potential shelters
- 9 are inadequate to house and protect the large numbers of
- 10 potential evacuees.
- 11 The evacuation of nursing home residents should be
- 12 considered only after all other options have been considered.
- 13 Enabling nursing homes to "shelter in place" their residents and
- 14 staff is the preferred alternative because it eliminates any
- 15 risks resulting from transportation and does not use scarce
- 16 emergency shelter resources. However, this option requires
- 17 confidence in the structural integrity of a nursing home.
- 18 In general, hospitals are typically more prepared than
- 19 nursing homes to address disasters. For example, hospitals have
- 20 comprehensive plans that will be implemented in the event of a
- 21 pandemic or terrorist attack. Still, the Katrina experience

- 1 underscores the need to assess hospital facilities as well, to
- 2 determine their ability to withstand hurricanes.
- 3 The purpose of this Act is to require the department of
- 4 health to assess the structural integrity of each hospital and
- 5 nursing home facility in Hawaii and appropriate moneys for this
- 6 purpose.
- 7 SECTION 2. The department of health shall assess the
- 8 structural integrity of each hospital and nursing home facility
- 9 in Hawaii. The assessment shall be conducted by one or more
- 10 registered professional engineers qualified to conduct
- 11 structural analyses on existing structures, and knowledgeable in
- 12 the effects of hurricanes, earthquakes, and other natural
- 13 disasters. The assessment shall include rating each facility
- 14 based on its ability to survive the likely effects of hurricanes
- 15 and earthquakes of various intensities, and other disasters.
- 16 SECTION 3. (a) The department of health shall provide the
- 17 results of the assessment to:
- 18 (1) Facility owners and operators to support preparation
- of risk-based disaster plans; and
- 20 (2) State and county civil defense officials to support
- 21 evacuation decisions.

- 1 (b) The department shall submit a report on its findings
- 2 and recommendations no later than twenty days prior to the
- 3 convening of the regular session of 2008.
- 4 SECTION 4. There is appropriated out of the general
- 5 revenues of the State of Hawaii the sum of \$, or so
- 6 much thereof as may be necessary for fiscal year 2007-2008, to
- 7 assess the structural integrity of all hospitals and nursing
- 8 homes in Hawaii to determine their ability to withstand
- 9 different types of natural disasters.
- 10 The sum appropriated shall be expended by the department of
- 11 health for the purposes of this Act.
- 12 SECTION 5. This Act shall take effect on July 1, 2020.
