### A BILL FOR AN ACT

#### BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1	SECT	ION 1. Section 612-16, Hawaii Revised Statutes, is
2	amended b	y amending subsection (e) to read as follows:
3	"(e)	[For the courts of the first circuit of the State

13	SECTION 2. Section 612-57, Hawaii Revised Statutes, is		
14	amended to read as follows:		
15	"§612-57 Grand jury counsel; duties. The grand jury		
16	counsel shall serve[ <del>, upon request of the grand-jury,</del> ] as		
17	independent legal counsel to the grand jury[ <del>, to be at the call</del>		
18	<del>of the grand jury</del> ] during its proceedings [ <del>in obtaining</del>		
19	appropriate advice] on matters of law after the grand jury has		
20	been sworn and charged by the court under section 612-16(d) and		
21	during the court's absence. The grand jury counsel [may] shall



10	SECTION 3. This Act does not affect rights and duties that
11	matured, penalties that were incurred, and proceedings that were
12	begun, before its effective date.
13	SECTION 4. Statutory material to be repealed is bracketed
14	and stricken. New statutory material is underscored.
15	SECTION 5. This Act shall take effect on January 2, 2008.
