A BILL FOR AN ACT

RELATING TO THE MOLOKAI IRRIGATION SYSTEM.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

SECTION 1. Section 167-23, Hawaii Revised Statutes, is 1 amended to read as follows: 2 "[+] §167-23[+] Molokai irrigation system [water users 3 advisory] governing board; establishment; meetings. (a) 4 is established a Molokai irrigation system [water users 5 advisory] governing board, to be appointed by the governor under section 26-34. The [advisory] governing board shall consist of 7 [six] eleven members, as follows: 8 [A] Six homestead farmer [user] users on Molokai[+], 9 (1)to be nominated to the governor by the Hoolehua 10 Homesteaders Association, Molokai Homestead Farmers 11 Alliance, and Hoolehua Homestead Agriculture 12 13 Association; 14 (2) A nonhomestead farmer user on Molokai; 15 (3) The designee (by name rather than office) of the Molokai Farm Bureau; 16

The designee (by name rather than office) of Hikiola 1 (4) 2 Cooperative, Inc.; 3 (5) The designee (by name rather than office) of the Molokai-Lanai soil and water conservation district; 4 5 and The designee (by name rather than office) of the 6 (6) department of Hawaiian home lands. 7 The members of the [advisory] Molokai irrigation system 8 9 governing board shall serve without compensation, but shall be 10 entitled to reimbursement for necessary expenses while attending 11 meetings and while in the discharge of their duties. For 12 administrative purposes, and pursuant to section 26-35, the [advisory] Molokai irrigation system governing board shall be 13 14 placed within the department of agriculture. The [advisory] Molokai irrigation system governing 15 (b) board shall meet with the department of agriculture at least six 16 17 times each year. The meetings shall be held on Molokai, 18 whenever possible. 19 The [advisory] Molokai irrigation system governing board's duties and responsibilities shall be to [advise the department 20 21 on matters of concern to the users of the system, manage the 22 Molokai irrigation system, to provide support for improvements

- 1 to the irrigation facilities, to participate in the long-range
- 2 planning of the system, and to act as liaison between the users
- 3 and the department."
