A BILL FOR AN ACT

RELATING TO HAWAII'S ECONOMY.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that, according to the
- 2 latest data from the United States Census Bureau, Hawaii's
- 3 population rose at its slowest rate in seven years in the year
- 4 ending June 30, 2007. This can be attributed to a number of
- 5 factors, including steep housing and property costs that have
- 6 resulted in commercial, industrial, and tenant rentals among the
- 7 highest in the fifty states; and increased out-of-state
- 8 investments that result in earnings leaving the State. The
- 9 resulting cost of living, which is one of the nation's highest,
- 10 has lead to an increased exodus of Hawaii residents in recent
- 11 years.
- 12 The legislature further finds that the various government
- 13 entities in Hawaii provide services that are among the most
- 14 extensive in the United States, yet these same government
- 15 agencies face rising operating and repair and maintenance costs
- 16 that must be passed on to the public. In addition, Hawaii's tax
- 17 structure affects businesses and consumers alike and has been

- 1 linked to the difficulty of attracting new investment to the
- 2 State.
- 3 The purpose of this Act is to authorize an independent
- 4 study and analysis of Hawaii's economy, including
- 5 recommendations for public policy changes that will begin to
- 6 address the cost of living, affordability, and quality of life
- 7 issues that Hawaii residents face.
- 8 SECTION 2. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$ or so
- 10 much thereof as may be necessary for fiscal year 2008-2009 for
- 11 an independent study and analysis of Hawaii's economy, including
- 12 recommendations for public policy changes that will begin to
- 13 address the cost of living, affordability, and quality of life
- 14 issues that Hawaii residents face.
- 15 The sum appropriated shall be expended by the department of
- 16 business, economic development, and tourism for the purposes of
- 17 this Act; provided that the department shall contract with an
- 18 out-of-state entity to conduct the study.
- 19 SECTION 3. The department of business, economic
- 20 development, and tourism shall report no later than twenty days
- 21 prior to the convening of the regular session of 2009 on the



- 1 results of the study, including any recommendations for changes
- 2 in public policies.
- 3 SECTION 4. This Act shall take effect on July 1, 2008.
