
A BILL FOR AN ACT

RELATING TO PUBLIC ASSISTANCE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

1 SECTION 1. The legislature finds that it is in the State's
2 best interests to ensure that women receive appropriate
3 interconception care following a pregnancy. In a report
4 presented to the Hawaii women's legislative caucus,
5 interconception care was defined as "a set of interventions that
6 aim to identify and modify biomedical, behavioral, and social
7 risks to a woman's health or pregnancy outcome through
8 prevention and management." Interconception care refers to the
9 set of care services between pregnancies.

10 By improving the health of women before the next pregnancy,
11 preconception and interconception care can improve the health of
12 the woman and her infant(s). Among other department of health
13 pregnancy risk assessment monitoring system data analysis
14 findings presented to the Hawaii women's legislative caucus:

15 (1) Women on QUEST are three times less likely to access
16 prenatal care in their first trimester of pregnancy;



- 1 (2) Compared to women with other health coverage, women
2 with QUEST coverage are 1.5 times more likely to have
3 an unintended pregnancy, three times more likely to
4 smoke during their last trimester of pregnancy, and
5 three to four times more likely to use illicit drugs;
- 6 (3) Compared to recently-delivering women with other
7 health coverage, women with QUEST coverage are twice
8 as likely to experience postpartum sadness or
9 depression and ten per cent more likely to have a low
10 birthweight or prematurely born infant;
- 11 (4) Compared to recently-delivering women with other
12 health coverage, women on QUEST were at three to four
13 times higher risk of experiencing intimate partner
14 violence while pregnant; and
- 15 (5) Compared to recently-delivering women with other
16 health coverage, women on QUEST were just as likely to
17 have their infants receive their first well-baby
18 check, but were two times more likely not to have
19 received the recommended post-partum check for new
20 mothers.

21 This data indicates that women with QUEST coverage are at
22 increased risk for poor pregnancy outcomes for their current, as



1 well as their future offspring. Improving interconception
2 health can result in improved reproductive health outcomes, with
3 potential for reducing societal costs as well. Interconception
4 care is intended to promote the health of women of reproductive
5 age before their next pregnancy, which can improve pregnancy-
6 related outcomes.

7 The State's QUEST program presently serves over 3,300
8 pregnant women a year, and covers the pregnant women for up to
9 sixty days after delivery. The legislature believes that it
10 would be in the best interests of the State for QUEST coverage
11 to be extended for six months following a pregnancy.

12 The purpose of this Act is to expand the period of coverage
13 under QUEST for interconception care services for six months
14 post-pregnancy.

15 SECTION 2. Chapter 346, Hawaii Revised Statutes, is
16 amended by adding a new section to be appropriately designated
17 and to read as follows:

18 "§346- Interconception care coverage. (a) The
19 department shall provide comprehensive coverage to pregnant
20 QUEST recipients for interconception care for a period of up to
21 six months post-pregnancy.



1 The department shall administer this benefit in a manner
2 that meets federal requirements that are a condition of the
3 receipt of federal funds by the State.

4 (b) For purposes of this section:

5 "Comprehensive coverage" means the full scope of preventive
6 and primary care services for women following a pregnancy.

7 "Interconception care" means a set of interventions that
8 aim to identify and modify biomedical, behavioral, and social
9 risks to a woman's health or pregnancy outcome through
10 prevention and management.

11 (c) Notwithstanding any law to the contrary, the
12 department shall make appropriate adjustments to the "rate of
13 payment per participating recipient" amount paid to health
14 maintenance organizations and prepaid health plans pursuant to
15 section 346-59(d), to allow for post-partum and intraconception
16 care coverage to QUEST recipients as defined in this section,
17 administered by a person licensed to practice medicine under
18 chapter 453. Health maintenance organizations and prepaid
19 health plans shall not be required to increase coverage to QUEST
20 recipients for post-partum and intraconception care administered
21 to QUEST recipients, as defined in this section, administered by
22 a person licensed to practice under chapter 453 until the



1 department makes adjustments to the "rate of payment per
2 participating recipient" amounts."

3 SECTION 3. There is appropriated out of the general
4 revenues of the State of Hawaii the sum of \$ or so
5 much thereof as may be necessary for fiscal year 2008-2009 to
6 expand the QUEST coverage for interconception care for pregnant
7 women for six months post-pregnancy.

8 The sum appropriated shall be expended by the department of
9 human services for the purposes of this Act.

10 SECTION 4. New statutory material is underscored.

11 SECTION 5. This Act shall take effect on July 1, 2008.
