# A BILL FOR AN ACT

RELATING TO EDUCATION.

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:**

1 SECTION 1. Act 246, Session Laws of Hawaii 2006, is amended  
2 by adding a new section to read as follows:

3 "SECTION 6A. There is appropriated out of the state  
4 educational facilities special fund the sum of \$90,000,000 or so  
5 much thereof as may be necessary for fiscal year 2006-2007 for  
6 the renovation of classrooms statewide in the department of  
7 education.

8 The appropriation made by this section shall not lapse at  
9 the end of the fiscal year for which the appropriation is made;  
10 provided that all moneys from the appropriation unencumbered as  
11 of June 30, 2010, shall lapse as of that date.

12 The sum appropriated shall be expended by the department of  
13 education for the purposes of this section."

14 SECTION 2. Act 246, Session Laws of Hawaii 2006, is amended  
15 by amending sections 4 and 5 to read as follows:

16 "SECTION 4. There is appropriated out of the general  
17 revenues of the State of Hawaii the sum of [\$160,000,000]



1 \$70,000,000 or so much thereof as may be necessary for fiscal  
2 year 2006-2007 for the renovation of classrooms statewide in the  
3 department of education.

4 The appropriation made by this section shall not lapse at  
5 the end of the fiscal year for which the appropriation is made;  
6 provided that all moneys from the appropriation unencumbered as  
7 of June 30, 2008, shall lapse as of that date.

8 The sum appropriated shall be expended by the department of  
9 education for the purposes of this section.

10 SECTION 5. The director of finance is authorized to issue  
11 general obligation bonds in the sum of [~~\$40,000,000~~] \$130,000,000  
12 or so much thereof as may be necessary, and the same sum or so  
13 much thereof as may be necessary is appropriated for fiscal year  
14 2006-2007 for repair and maintenance of department of education  
15 school facilities[-], including the renovation of classrooms.

16 The appropriation made by this section shall not lapse at  
17 the end of the fiscal year for which the appropriation is made;  
18 provided that all moneys from the appropriation unencumbered as  
19 of June 30, [~~2008~~], 2010, shall lapse as of that date.

20 The appropriation made by this section shall be deposited in  
21 the state educational facilities special fund.



1 The sum appropriated shall be expended by the department of  
2 education for the purposes of this section."

3 SECTION 3. Act 213, Session Laws of Hawaii 2007, is amended  
4 by amending section 125, part G, item G-4 to read as follows:

5 "4. LUMP SUM CIP - SCHOOL BUILDING IMPROVEMENTS, STATEWIDE

6 DESIGN AND CONSTRUCTION FOR THE

7 IMPROVEMENTS OF PUBLIC SCHOOL

8 FACILITIES, STATEWIDE. MAY

9 INCLUDE PROJECT MANAGEMENT AND

10 CONSTRUCTION MANAGEMENT SERVICES,

11 ROOFING, AIR CONDITIONING,

12 PAINTING, PLUMBING, AND OTHER

13 REPAIRS AND IMPROVEMENTS TO PUBLIC

14 SCHOOL FACILITIES.
